It is further awarded that all affected employees available as at that date shall have been back at their places of work not later than 15th November, 1982.</p> <p data-bbox="792 1342 1210 1608">This Award shall take effect as if the affected employees had never been laid off, and are to be treated during their enforced absence from their employment as being on leave without pay and shall not be subject to disabilities whatsoever in consequence thereof.</p> <p data-bbox="792 1627 1210 1751">(b) Every reinstated employee in (a) above, shall be paid an <i>ex gratia</i> allowance of a sum equivalent to their salary/wages</p>

for a period not less than three calendar months ; payment to be made not later than 25th November, 1982.
