Section 1 of the Allocation of Revenue (Federation Account, etc.) Amendment to section 1 of 1982 No. 1. Act 1981 is hereby amended-(a) in paragraph (a) thereof, by substituting for the figure "55" the new figure "50"; and 6 7 (b) in paragraph (c) thereof, by substituting for the figure "10" the 8 new figure "15". 2. This Act may be cited as the Allocation of Revenue (Federation 10 Account, etc.) (Amendment) Act 1983.
