Kankanamman Sumanasena Kulasinghe Deportation Order 1984

I, the Minister of Internal Affairs, being of the opinion that Kankanamman Sumanasena Kulasinghe at present in Nigeria ought to be classified as a prohibited immigrant and acting under the powers conferred upon me by section 18 (3) of the Immigration Act 1963, and of all other powers enabling me in that behalf, accordingly order that the said Kankanamman Sumanasena Kulasinghe be so classified and further order that the said Kankanamman Sumanasena Kulasinghe be deported from Nigeria by the first available means and 1 direct that the said Kankanamman Sumanasena Kulasinghe shall thereafter remain out of Nigeria.

2. This Order may be cited as the Kankanamman Sumanasena Kulasinghe C. Deportation Order 1984.

Carlos Antoun Wehbe (Prohibited Immigrant) Order 1984

Commencement : 21st March, 1984

I, the Minister of Internal Affairs being of opinion that the admission of Carlos Antoun Wehbe into Nigeria would be contrary to the interest of national security and is therefore, in accordance with the provisions of section 17 (1) (d) of the Immigration Act 1963, deemed to be a prohibited immigrant, and acting under the powers conferred upon me by section 17 of the said Act, and of all other powers enabling me in that behalf, order that the said Carlos Antoun Wehbe be refused admission into Nigeria-accordingly.

This Order may be cited as the Carlos Antoun Wehbe (Prohibited Immigrant) Order 1984.
