In exercise of the powers conferred upon it by Section 29 of the Council for the Regulation of Freight Forwarding in Nigeria Act 2007 and all other powers enabling it in that behalf, the Governing Council of Council for the Regulation of Freight Forwarding in Nigeria makes this Regulation—

1. The Council for the Regulation of Freight Forwarding in Nigeria (CRFFN) (Organs and Offices of the Council) Regulation 2010 ("the Principal Regulation") is further amended as set out in this Regulation.

2. Regulation 2 of the Principal Regulation is amended by inserting a new regulation 2 to replace the existing regulation 2 as follows—

"2. The Governing Council shall be the highest policy organ of the Council and shall be composed of members elected and those appointed as prescribed in section 2 of the CRFFN Act and whose powers and functions shall include".

3. Regulation 2 is further amended by inserting a new item 2(d) immediately after the existing item 2(c) as follows—

"2(d) Ratify decisions and actions taken by the Chairman, in conjunction with the Vice-Chairman and five (5) other members in furtherance of the goals of any regulation or in a situation of emergency or so acting in the general interest of the Council".

4. The principal regulation is amended by renumbering the existing item 2(d) as item 2(e) and subsequently renumbering the following items.

5. Regulation 6 (1) of the principal Regulation is amended to read as follows—

"6(1) The Governing Council shall appoint a fit and proper person to be the Registrar subject to the provisions of the Act and he shall report to the Chairman of the Governing Council; his duties and responsibilities shall include..."

6. Regulation 6(1) item (c) is amended to read as follows: "Preparing the list for appointment of staff subject to approval by the Governing Council".

7. Regulation 6(1) is amended by deleting the existing items (f) and (k), and re-nunbereing the existing items as follow s: “(c), (d) (e), (f), (g), (h), (i), (j), (k), (l), (m), and (n)”.

8. Regulation 6(1) is further amended by inserting “subject to approval by the Governing Council”, immediately after each of the following items “(a), (c), (d) (e), (f), (g), (h), (i), (j), (k), (l), (m), and (n)”.

9. Regulation 6(2) of the principal Regulation is amended to read as follows : “The Registrar shall have power to conduct and conclude transactions not exceeding the amount of Two Million, Five Hundred Thousand Naira Only (N2,500,000).”

10. Regulation 6 of the principal regulation is further amended by inserting a new sub-regulation (3) to read as follows—

“6(3) The appointment of the Registrar shall be for a period of four (4) years, renewable for another 4 years and no more. However, the appointment of the Registrar shall be determined by the Governing Council, subject to the performance of his duties and responsibilities.

11. The Governing Council may from time to time amend or repeal the provisions of this Regulation.
