NOTICE OF APPROVAL OF MESSRS LADOL INTEGRATED FREE ZONE ENTERPRISES (LADOLFZ) AND MESSRS SNAKE ISLAND INTEGRATED FREE ZONE (SIIFZ) TO RESPECTIVELY OPERATE AS WHARF WITHIN APAPA AND TIN-CAN ISLAND PORT, 2019

In exercise of the powers conferred on it by section 14 of the Customs and Excise Management Act Cap. C45 Laws of the Federation of Nigeria, 2004 and all other powers enabling it in that behalf, the Nigeria Customs Service management Board issues the following Approval Notice—

[30th Day of March, 2019]

1.—(1) The following enterprises are approved to operate as wharves at custom port—

(a) Messrs Ladol Integrated Free Zone Enterprise (LADOLFZ) is to operate as a Wharf within Apapa Port ; and

(b) Messrs Snake Island Integrated Free Zone (SIIFZ) is to operate as a Wharf within Tin-Can Island Port.

2.—(a) LADOLFZ and SIIFZ shall ensure maintenance of facilities for direct foreign and local shipping within their zones.

(b) LADOLFZ shall ensure compliance with Apapa Port Management Traffic Rules.

(c) SIIFZ shall ensure compliance with Tin-Can Port Management Traffic Rules.

(d) LADOLFZ and SIIFZ shall ensure compliance with Nigeria Ports Authority Regulations.

(e) LADOLFZ vessels shall report to the Nigerian Customs Service officers of Apapa posted to LADOLFZ for the purpose of boarding, rummaging, break bulk, discharge and report of departure etc.

(f) SIIFZ vessels shall report to the Nigerian Customs Service officers of Tin-Can Port posted to SIIFZ for the purpose of boarding, rummaging, break bulk, discharge and report of departure etc.

(g) LADOLFZ and SIIFZ shall ensure compliance with all extant Customs laws, regulations, Notices, Codes and Circulars.

3. This notice may be cited as notice of approval of Messrs Ladol Integrated Free Zone Enterprise (LADOLFZ) and Messrs Snake Island
