Nigeria (Constitution) Orders in Council, 1954 and 1955 APPOINTMENT OF ACTING FEDERAL JUSTICE



By His Honour Sir Ralph Francis Alnwick Grey, Knight/Commander of the Royal Victorian Order, Companion of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, Deputy, Governor-General.

WHEREAS by section 138 of the Nigeria (Constitution) Order in Council, 1954, it is provided that the Judges of the Federal Supreme Court shall be a Chief Justice of the Federation, two Federal Justices, or such greater number as may be prescribed by or under any law enacted by the Federal Legislature, and such acting Federal Justices as may be appointed :

AND WHEREAS by paragraph (b) of subsection 3 of section 139 of the anid Order in Council the Governor-General acting in his discretion may appoint a person qualified for appointment as a Federal Justice to act as a

Federal Justice:

AND WHEREAS by Instrument under the Public Seal of the Federation of Nigeria dated the eleventh day of March, 1958, the Governor-General has appointed the Deputy Governor-General; as Governor-General's Deputy, to exercise and perform and execute certain functions on his behalf during his absence from Lagos and such functions include the power of appointment of an acting Federal Justice referred to in the last recital:

AND WHEREAS the Governor-General is absent from Lagos and such absence has been notified in the Official Gazette of the Federation:

Now THEREFORE, I, RALPH FRANCIS ALNWICK GREY, Knight Commander of the Royal Victorian Order, Companion of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, Deputy Governor-General of the Federation of Nigeria, as Governor-General's Deputy, do hereby appoint GRONGE FREDRACK DOVE-EDWIN to act, during the pleasure of the Governor-General, as a Federal Justice as from the 31st day of March, 1958, and until further notice.
