Government Notice No. 682

Customs Ordinance (Chapter 48)

DRAWBACK

Attention is drawn to the Customs (Drawback) Regulations, 1958, published as Legal Notice No. 72 of 1958 in the Supplement to *Official Gazette* No. 29 of 3rd April, 1958. They replace Part V of the Customs Regulations, 1945.

2. The new regulations provide for the following changes:—

(a) drawback is increased from 95 per cent to 100 per cent of the import duty paid;

(b) drawback may now be paid on the exportation of goods by overland routes approved by the Comptroller (see paragraph 4);

(c) drawback may now be paid upon the exportation of goods manufactured in Nigeria from imported duty-paid materials.

3. No drawback may be paid—

(a) where the goods are exported or used as prescribed more than 2 years after the date of report of the importing vessel;

(b) unless the drawback is claimed within one year of exportation or prescribed use, as the case may be;

(c) where, in the opinion of the Comptroller, the value of the goods has substantially depreciated;

(d) where, in the opinion of the Comptroller, the goods are exported with a view to re-importation;

(e) unless the goods upon which drawback is claimed were imported by or on behalf of the exporter or user, as the case may be;

(f) unless the goods are perfectly entered at import;

(g) unless payment of import duty, exportation and/or prescribed use are proved to the satisfaction of the Comptroller;

(h) unless, if so required, the claimant produces a certificate of the landing abroad of goods exported;

(i) unless the directions of this notice and such other directions as the Comptroller or proper officer may give are carried out.

4. The Comptroller hereby approves the Customs Post at Idiroko on the road from Lagos to Dahomey as a place through which goods may be exported on drawback.

5. *Goods Exported in the Same State as Imported.*—Drawback amounting to 100 per cent of the import duty paid may be claimed upon the exportation of imported goods provided—

(a) the goods are in the original containers as imported and have not been disturbed or repacked except as may be allowed by the Comptroller;

(b) the goods are entered for exportation on Form C.2 in quadruplicate;

(c) drawback is claimed on Form C.3 in triplicate;

(d) the requirements of paragraph 3 of this notice are complied with.

6. *Exported Goods Manufactured in Nigeria from Duty-Paid Materials.*—Drawback of 100 per cent of the import duty paid may be claimed upon the exportation of goods manufactured in Nigeria from imported materials.

7. In addition to the general conditions specified in paragraph 3 of this notice the terms of the following paragraphs must be carried out by a person claiming "materials" drawback:

8. Any person intending to claim drawback after manufacture of imported materials must give the Comptroller notice of his intention to do so before he imports the materials (see paragraph 12). He must, in addition to carrying out the terms of this notice, carry out such further requirements as the Comptroller may specify.

9. The materials must be entered at import on the normal forms, an extra copy of the form, marked "for drawback purposes only" being submitted. This copy, after the entry has been passed, will be returned to the importer for incorporation in the accounts required to be kept under paragraph 11 below. Each copy of the entry must bear a declaration that the goods will be used in manufacture in Nigeria and will be exported on drawback. For the sake of convenience these materials are referred to in this notice as "drawback materials".

10. Drawback materials must be stored separately at the factory from other goods.

11. Full records must be kept, at the factory, of the receipt and disposal (including use in manufacture) of all drawback materials and of the goods made therefrom. Separate records may, if desired, be kept of different materials and of different processes but it is essential that it should be possible to trace all materials through the records from importation to exportation as the finished product.

12. No set form of records is laid down as it is desired to make as much use as possible of the manufacturer's own records. Because, however, it is likely that these records will require some adaptation for drawback purposes, manufacturers are advised, in their own interests, to make very sure that the prior notice required in paragraph 8 above, is given.

13. Drawback is payable on the quantity of drawback materials used in the manufacture of the exported goods. Unusable waste, therefore, qualifies for drawback provided it is produced to the officer and destroyed in his presence. Usable surplus, however, does not qualify until further used in manufacture and exported.

14. There is no objection to the use or disposal of drawback materials for purposes other than drawback provided such use or disposal is properly accounted for in the records kept under paragraph 11.

15. The proper officer of Customs and Excise may at all reasonable times enter the manufacturer's premises and there examine such goods, processes, books and records as he considers necessary with a view to verifying drawback claims.

16. The officer may also take such samples as he may from time to time consider necessary for the purpose of verifying drawback claims.

17. Goods must be entered for export on Form C.2 (Export entry for goods eligible for drawback) in sextuplicate. A copy of the entry, after certification by the officer, will be returned to the exporter for attachment to his claim for drawback.

18. Claims for drawback must be made on Form C.3 (Drawback Debiture) and must be supported by the certified copies of export entries mentioned in paragraph 17.

19. Claims should be submitted to the Comptroller of Customs and Excise, Customs and Excise Headquarters, Lagos.

20. No claim for less than £50 drawback will be entertained.

21. Should the manufacturer be a beneficiary under the Industrial Development (Import Duties Relief) Ordinance, 1957, drawback will be confined to such a sum as, together with the relief afforded under that Ordinance, amounts to 100 per cent of the import duties paid.

OTHER "MATERIALS" DRAWBACKS

22. Certain goods qualify for "materials" drawback even though not exported. The requirements of paragraphs 8 to 16 and 19 to 21 above apply equally to such goods.

23. Claims should be made on Form C.3 in triplicate and forwarded to the Comptroller of Customs and Excise, Customs and Excise Headquarters, Lagos.

24. The above general requirements may be amplified or amended in respect of any particular trader.

25. This notice in no way alters the provisions of the law as laid down in the Customs Ordinance and the Customs (Drawback) Regulations, 1958. Its purpose is merely to explain official requirements to interested persons.

HOSPITAL FEES

With effect from the 1st May, 1958, revised charges in respect of Hospital Fees will be introduced at the rates laid down below which have been approved by the Federal Government.

The only fees payable will be those scheduled below and no payment should be made without obtaining an official printed receipt. The Fee Collecting Stations for Out-Patients will be based in the General Out-Patient Department, the Casualty Department and the Ante-Natal Department. The Fee Collecting Station for all In-Patient charges will be based in the Central Medical Records Department.

Regulations

HOSPITAL FEES

In exercise of the powers conferred upon the Board of Management by Section 15 (2) (n) of the University College Hospital Ordinance, 1952, the following regulations in respect of fees payable by patients are hereby made:—

A.—EXEMPTIONS FROM ALL CHARGES

No charges shall be levied for accommodation, maintenance or medical or nursing attention, on the following:

(a) Members of the Medical, Dental and Nursing professions and hospital auxiliaries and their wives and children;

(b) All other members of the Medical Departments of the Governments of the Federation, and members of the staff of the University College Hospital and their wives and children;

(c) Unestablished staff employed in the University College Hospital or in Government hospitals and dispensaries and their wives and children;

(d) Persons certified as paupers; *

(e) Persons receiving treatment or advice for pulmonary tuberculosis and other notifiable infectious disease, or incurable malignant disease;

(f) Persons who, on the certification of the Doctor in charge of the case, are admitted to or retained in hospital solely for the purposes of teaching and/or research. (The certificate should show the date on which the patient would normally have been discharged and fees should be charged up to that date.)

(g) All African Other Ranks of Her Majesty's Armed Forces, below Non-Commissioned Officer rank;

(h) All Constables of the Nigeria Police Force.

* See Regulation D. XIII.

B.—IN-PATIENTS

I. Charges for Maintenance and Accommodation only.—Charges for maintenance and accommodation only shall be levied on the persons listed below:

(i) Persons in the service of Government and Government pensioners, including:

the wife and children of a member of the established staff of Government;

a member of the staff of the British Council and his wife and children;

a member of Her Majesty's Armed Forces (including a civilian employee of the Armed Forces who is entitled to medical attention and treatment by the Armed Forces or under the National Health Service of the United Kingdom), and his wife and children, subject, nevertheless, to the provisions of Regulation 23 of the Hospital Fees Regulations;

the holder of a post on the Permanent Establishment of a Local Government Council or Native Authority, and his wife and children;

the holder of a post on the Permanent Establishment of the University College, Ibadan, or the Nigerian College of Arts, Science and Technology, and his wife and children;

a member of the Federal House of Representatives, his wife (or wives) and children, while attending meetings of the House, but not its Committees;

a member of the Council of Ministers, his wife (or wives) and children;

a member of the Board of Management of University College Hospital, his wife and children;

a member of the Privy Council of the Federation, his wife (or wives) and children.

(ii) A Missionary wholly employed in educational work.

(iii) A teacher employed at a Government Assisted School, his wife and children.

(iv) All children under the age of 16 years (with the exception of charges made for spectacles and dentures).

(v) The servants of officers in the service of the Government or of officers holding senior appointments in the University College Hospital, University College and the Nigerian College of Arts, Science and Technology.

Charges for accommodation and maintenance of persons referred to above shall be at the following daily rates:—

II.—Charges for Treatment, Accommodation and Maintenance.—Inclusive charges for medical and nursing attention, accommodation and maintenance, shall be levied on all other persons at the following daily rates :—

III. Amenity Beds.—Inclusive charges for medical and nursing attention, accommodation and maintenance shall be levied on all persons admitted to Private Wards at their own request (and irrespective of whether they are included in any of the categories in Sections A and B above) at the rate of £1-10s-0d per day, subject to a maximum charge of 80 guineas.

C.—OUT-PATIENTS

IV. Exemptions.—No charges for out-patients treatment of any kind will be levied on the persons listed in paragraphs A and B, I above, or on patients referred from outside hospitals or medical practitioners direct to Specialist Consultant Clinics or to the Casualty Department.

Charges will be levied on all other persons as follows :

V. General Out-Patients.—On first attendance a fee of 4s will be charged to cover all treatment for one week from the date of payment. A further charge of 4s will be made for each subsequent period of one week or part thereof.

VI. Casualty Department.—A similar charge to that stated in paragraph V will be payable and the payment of 4s, whether made in the General Out-Patients Department or the Casualty Department, will be valid for treatment for a period of one week in either of the departments.

VII. The payments stated in paragraphs V and VI may be deferred at the discretion of the Doctor or Sister in charge at the time of attendance of a seriously ill patient. In such a case the charge becomes payable at the time of the next visit.

VIII. Ante-Natal Clinic.—A fee will be payable at the time of booking to cover all attendances during pregnancy and attendances at the post-natal clinic until discharged. This fee will be related to the fee charged at Adeoyo Hospital for similar services (at date of publication of these Regulations, 10s). The fee charged will not include maintenance in hospital, for which the charges laid down in Sections B, I and II of the Regulations will be applicable.

IX. Other Services for Out-Patients.—There will be no additional charge for the following services :

Attendance at Specialists clinics for patients referred through the General Out-Patient Clinic or the Ante-Natal Clinic ;

X-Ray, Laboratory or other investigations ;

Out-Patient physiotherapy treatment ;

Drugs and dressings supplied to out-patients by the Hospital Pharmacy ;

Attendance at the Infant Welfare Clinic.

Out-Patients referred from outside sources to the General Out-Patients Department will pay at the rate stated in paragraph C, V above

D.—GENERAL

X. Fees payable by an In-Patient shall be assessed on the basis of the basic income of such patient ; a married woman shall be charged at the rate applicable to her husband or according to her own income, whichever may be higher.

XI. All sums due are payable on discharge from Hospital to the Hospital Authorities, but an In-Patient may be asked to deposit at intervals an amount as may be determined by the Hospital Authorities towards the cost of his final hospital bill. Sums received by the Hospital Authorities should be paid into the account of the Hospital and shown in the annual Financial Accounts of the Hospital.

XII. A senior appointment, for the purposes of these Regulations, is one carrying an initial basic salary of £516 per annum or more.

XIII. A pauper certificate must be signed by one of the following ;

(a) A Minister of religion or Imam

(b) A Registered Medical Practitioner

(c) The Resident or District Officer or any Administrative Officer of equivalent rank or the Chairman of the Local Government Council in the area in which the patient resides

(d) A Magistrate or Alkali

If a pauper cannot produce such a certificate, the Almoner shall have authority to issue the certificate if she is satisfied that the patient is in fact a pauper.
