## Nigeria (Constitution) Orders in Council, 1954 and 1955

## APPOINTMENT OF ACTING FEDERAL JUSTICE



By His Excellency SIR JAMES WILSON ROBERTSON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of the Royal Victorian Order, Knight Commander of the Most Excellent Order of the British Empire, Governor-General and Commander-in-Chief of the Federation of Nigeria.

WHEREAS by section 138 of the Nigeria (Constitution) Order in Council, 1954, it is provided that the Judges of the Federal Supreme Court shall be a Chief Justice of the Federation, two Federal Justices, or such greater number as may be prescribed by or under any law enacted by the Federal Legislature, and such acting Federal Justices as may be appointed :

AND WHEREAS by paragraph (b) of subsection 3 of section 139 of the said Order in Council the Governor-General acting in his discretion may appoint a person qualified for appointment as a Federal Justice to act as a Federal Justice :

NOW THEREFORE, I, JAMES WILSON ROBERTSON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of the Royal Victorian Order, Knight Commander of the Most Excellent Order of the British Empire, Governor-General and Commander-in-Chief of the Federation of Nigeria, do hereby appoint WILFRED HUGH HURLEY to act during my pleasure, as a Federal Justice as from the 5th day of May, 1958, and until further notice.

Note: In the following Notice:—

the "exporter" means the person or firm consigning the goods to the Nigerian importer;

the "supplier" means the person or firm who supplies the goods to the foreign exporter (the term "supplier" is normally used in connection with 'raw material' goods which have not been processed or manufactured); and

the "manufacturer" means the person or firm who actually manufactured the goods.

Importers and overseas exporters are deemed to be associated if, whether directly or indirectly, either of them has any interest in the business or property of the other or both have a common interest in any business or property, or some third person has any interest in the business or property or both of them, and includes cases where;

- (a) they are under common management;
- (b) one is a branch of the other;
- (c) one is a subsidiary of the other;
- (d) one is a buying agent of the other;
- (e) one or more directors are common to both;
- (f) the owners of the two businesses are members of the same family.

1. As from Monday, 1st September, 1958, the following documents must be presented at Customs Houses in support of each entry for trade goods imported by sea or air.

(a) For trade goods liable to *ad valorem* duty imported from the United Kingdom by a person or firm associated with the exporter—two sets of invoices from the suppliers or manufacturers of the goods or

(b) For trade goods liable to *ad valorem* duty imported from any country other than the United Kingdom—two sets of each invoice necessary to trace the transaction back to the actual manufacturer of the goods, i.e.,—

two sets of suppliers invoices, and, where the supplier is not the manufacturer, two sets of manufacturers' invoices.

In addition to the foregoing for all trade goods irrespective of the country of exportation or of their liability to duty, if any, two sets of invoices from the exporter, accompanied, as hitherto, by the normal Certificate of Origin and Value (i.e., 'attested' invoices).

2. Each set of original invoices must be attached to the original Bill of Entry, and duplicate sets to the second copy of the entry. Each duplicate set must, of course, be an exact copy of the original and great care must be exercised to ensure that each set is complete and separate, otherwise entries will be rejected.

3. All the above enumerated copies of invoices will be retained by the Comptroller. They will, in no circumstances, be returned to the importer or his agent.

4. WHEN MANUFACTURERS' INVOICE NOT AVAILABLE.—Relaxation of the requirements set out in this Notice will only be given in exceptional circumstances, and then only by an officer not below the rank of Assistant Comptroller or Principal Collector in the case of the Delta Ports only.
