PRESCRIPTION BY THE GOVERNOR-GENERAL OF THE NUMBER OF MINISTERS TO BE APPOINTED IN ADDITION TO THE PRIME MINISTER

In pursuance of the provisions of section 88 of the Nigeria (Constitution) Order in Council, 1954 (as amended by the Nigeria (Constitution) (Amendment No. 2) Order in Council, 1957), and on the recommendation of the Prime Minister, I have prescribed that until further prescription the number of Ministers who shall be appointed in addition to the Prime Minister shall be TEN.

This Prescription is in substitution for that dated the 31st day of August, 1957, which was published as Government Notice No. 1588 of 1957.

RE-ASSIGNMENT OF MINISTERIAL RESPONSIBILITY IN RESPECT OF CERTAIN MATTERS

It is announced that the Governor-General, on the recommendation of the Prime Minister, and in accordance with the provisions of section 98 of the Nigeria (Constitution) Order in Council, 1954, has directed that with effect from the 28th day of July, 1958, the Ministers specified in the first column of the Schedule to this notice are charged with responsibility for the matters or groups of matters set out against their respective names in the second column of such Schedule, and with responsibility for the departments of Government set out in the third column of that Schedule.

The appropriate titles of the said Ministers are those specified in the fourth column of such Schedule.
