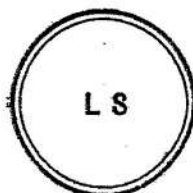

These awards are tenable in Universities and institutions of higher learning in the appropriate Commonwealth Country and are open to men and women (normally resident in Nigeria) who show evidence of high intellectual promise and are expected to make a significant contribution to life in this country on their return. The awards provide opportunities for post-graduate study or research. Only in special circumstances may they be held for under-graduate study or for courses offered in residential colleges of adult education or at colleges offering diplomas in fine art or industrial design. They are not intended for those seeking initial or advanced training as teachers for whom there is a separate scheme under the Commonwealth Teacher Training Bursary.

3. *Tenure.*—The Scholarship is tenable for a programme of study or research normally extending over a period of two academic years and leading to a University degree or similar qualification. In some cases an award may be made for one academic year only and in appropriate circumstances (e.g., a post-graduate course that may require three years to complete) the award may be extended for a third year.

4. *Emoluments.*—The emoluments will cover expenses of travel, living and study during tenure of the scholarship as well as an initial clothing grant and a marriage allowance in the case of scholars accompanied by their wives.

5. *Eligibility.*—Candidates must be graduates of a University or College or holders of an equivalent qualification. They must be NIGERIANS and normally resident in this country. Only in exceptional cases may consideration be given to those who are already studying in the Commonwealth country of their choice.

6. *Age limit.*—Candidates must be under 35 years of age on 31st October, 1961 but preference will be given to those who are between 22 and 28 years of age.
