"(i) a good honours degree from a recognised University in either English, Modern Languages, Botany, Chemistry or Zoology" and substitute the following:

"(i) a good honours degree of a British or other acceptable University in any subject taught in Secondary Schools in Nigeria; together with"

Also in paragraph 2, under Scale of salary, delete "(b) Contract—Group 9 plus 10 per cent contract addition—£1,896 per annum" and substitute the following:

"As only Nigerians are eligible for consideration for supernumerary posts, the successful candidate will be appointed to the permanent and pensionable staff."
