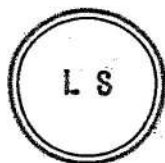

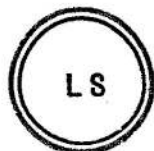

A BILL for an Act to amend the Flags and Coats of Arms Act, 1960, by making better provision for the National Flag and other Flags in Nigeria.	The Bill seeks to replace the Flags and Coats of Arms (Amendment) Act, 1961, and to provide for the circumstances in which the National Flag, the Flag of any Region or the Flag of any Commonwealth or foreign country may be flown. Provision has also been made for the flying by any ship, other than a Nigerian ship of the National Flag and the Flag of the country where the ship is registered.	7-12-62	12-12-62
A BILL for an Act to adjust the boundaries of Tafawa Balewa Square in the Federal Territory.	Completion of Independence House and its forecourt will require the re-alignment of King's College Road. To this end, a small strip of land has had to be excised from the area of Tafawa Balewa Square as shown in Part I of the First Schedule to the Tafawa Balewa Square Management Act, 1961 and an equivalent area of Crown land contiguous to the area of the Square substituted therefor and embodied in the total area. A BILL for an Act to consolidate and amend the law as to Weights and Measures and to make provision for metric weights and measures and for connected matters.	The Bill seeks to make amended provision with respect to Weights and Measures with a view to establishing uniform standards of weights and measures throughout the Federation and to ensure that these standards correspond to internationally recognised ones and are periodically compared and adjusted. Provision is also made under the law for punishing any attempts at fraud and misrepresentation in weighing and measuring.	12-12-62	13-12-62
A BILL for an Act to consolidate and amend certain enactments relating to diplomatic immunities and privileges.	The Bill extends to diplomatic representatives from other countries, the like immunities and privileges as are accorded abroad to the representatives of our own nation; and seeks to grant the immunities and privileges to organisations such as those of the United Nations and any others from time to time recognised by Nigeria as being in accordance with diplomatic practice.	13-12-62	14-12-62

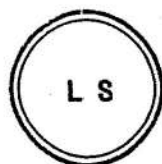

A BILL for an Act to constitute a Sports Council for the Federal territory ; to provide for the provisional membership and ratify the exercise of powers ; to confer on the Sports Council sundry powers and duties ; and for connected purposes.	The Bill provides for the establishment of a Lagos Sports Council which will be primarily concerned with the development of and participation in amateur sports. The Council should exercise control, where necessary, over the activities of sports clubs, matches, competitions and their participants.	12-12-62	13-12-62
A BILL for an Act to amend the law relating to income tax.	The Bill seeks to amend the Income Tax Management Act, 1961, the Companies Income Tax, 1961 and the Personal Income Tax (Lagos) Act, 1961, so that some inadvertent minor omissions from those Acts may be corrected and minor improvements arising from experience in the administration of those Acts can be effected.	7-12-62	12-12-62

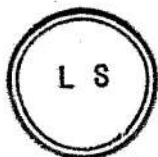

<i>Long Title of Bill</i>	<i>Summary of Contents</i>	<i>Date passed by House of Representatives</i>	<i>Date passed by Senate</i>
A BILL for an Act to amend the law relating to Customs and Excise.	The Bill provides for exemption from customs duties of goods which are exported temporarily; empowers the Board of Customs and Excise, in cases where it would be inequitable to charge the full duty on composite goods, to charge duty on the goods by reference to the rates of duty applicable to the ingredients contained in the goods; provides for exempting from excise duty spirits manufactured in Nigeria which are exported or loaded as stores in accordance with the customs or excise laws and provides for the warehousing of dutiable goods manufactured in Nigeria. It also empowers the Board to require the holder of an excise licence to provide suitable living accommodation for an excise officer where necessary; enables the Board to demand administrative expenses from a person who claims repayment of excess duty; provides for the arming of all Customs Preventive Officers while they are under the supervision of Senior Preventive Officers; empowers any officer authorised in writing by the Board to search premises licensed under the Liquor (Licensing) Act, 1959, and prescribes penalties for offences in connection with the clause.	12-12-62	13-12-62

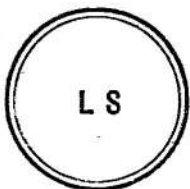

The Provincial Administration Law, 1962, of Northern Nigeria designates the Ministers of the Region responsible for administering provinces as Provincial Commissioners, and transfers to them the functions of the Resident in so far as it is within the power of the Regional Legislature to do so. The Bill makes the consequential adaptation necessary for transferring to the Provincial Commissioners the functions conferred on Residents by Federal Law.	13-12-62	14-12-62
