

NIGER DELTA DEVELOPMENT BOARD

VACANCIES FOR SENIOR STAFF

Applications are invited from suitably qualified Nigerian candidates for the following posts in the service of the Niger Delta Development Board. The Board is charged under the constitution of the Federation with undertaking a survey of the Niger Delta Area in order to ascertain what measures are required to promote its physical development and with the preparation of schemes designed to promote that development. The Constitution also provides that the life of the Board shall expire on the 1st July, 1969, unless extended by Parliament. The headquarters of the Board are sited at Port Harcourt.

A. CIVIL ENGINEER/HYDROLOGIST

Duties.—The Officer will be required to undertake Engineering and Hydrological investigations and

advise on road and waterways development including flood control measures in the Niger Delta Special Area.

Qualifications.—Applicants must possess either a university degree or diploma in Civil Engineering recognised by the Institution of Civil Engineers or the equivalent of a university degree from Institutions recognised in the country of origin. In addition training in Hydrology is essential but experienced engineers without hydrological training may apply. A successful candidate with Engineering qualification only may be required to undergo training in hydrology.

B. FORESTRY OFFICER

Duties.—The Forestry Officer will be required to undertake research and investigation on Forest products and tree crops throughout the special area. He will advise on the promotion and preservation of forest resources and the utilisation of forest products.

Qualifications.—Applicants must possess a university honours degree in Forestry and preferably some practical experience in the field, particularly in the utilisation of forest products.

C. AGRICULTURAL OFFICER

Duties.—The Agricultural Officer will be required to undertake research and investigations, including the carrying out of a series of pilot projects throughout the Niger Delta Special Area. He will advise on the improved production of existing and new crops, and the introduction of new farming methods.

Qualifications.—Applicants must possess a university honours degree in Agriculture with some experience preferably in Agricultural field problems, farm management and the economic application of results of agricultural research.

Officers selected for appointment to the above posts A, B, C would be required to work under the guidance of experts appointed under technical assistance arrangements during the first three years of their engagement. At the end of this period they may be required to take over full responsibilities.

D. ACCOUNTANT

Duties.—The successful candidate will be required to carry out normal duties of an accountant in a commercial organisation. He will be working under the Chief Accountant of the Board and may be required on occasions to act for the Chief Accountant.

Qualifications.—Applicants must possess one of the following qualifications:—

- (ii) Associate membership of the Association of Certified and Corporate Accountants.
- (iii) Honours Degree in Economics or equivalent with Accountancy as a special subject.

E. ASSISTANT WORKS SUPERINTENDENT

Duties.—The Assistant Works Superintendent will carry out the duties assigned to him by his superior officers which will include:—

- (i) Supervision of construction of buildings, or roads.

- (ii) Maintenance of buildings.

- (iii) Supervision of any engineering or other works undertaken by the Board in pursuit of its obligations.

Qualifications required:—

- (i) Five years' apprenticeship and at least two years practical experience.

- (ii) Completion of the Federal Ministry of Works and Surveys' course for Assistant Works Superintendents together with suitable experience.

Conditions of service.—Salaries for posts A, B, C and D are at present in scale A of the Federal Government (£720 to £1,584 per annum); the salary of post (E) is in the scale C(T) 1, 2 (£330-855).
