Public Lands Acquisition Act (Chapter 167)

LAND REQUIRED FOR THE SERVICE OF THE FEDERAL GOVERNMENT

NOTICE is hereby given that all those parcels of land at Bonny in the Rivers Province, Eastern Nigeria, the boundaries of which are herein described are required by the Governor-General for public purposes absolutely and in particular for officers Quarters and Access Road.

DESCRIPTION—PARCEL "A"

All that parcel of land at Bonny in the Rivers Province containing an area of approximately 4.59 acres in the area known as the Park, the boundaries of which are described as below :—

Starting at a temporary concrete pillar marked TBM1 which is 2.0 feet North of a radio mast in front of the Decca Navigator's house, which is in the land belonging to Shell-B.P.D.P.Co. Limited, the boundaries run in straight lines and the bearings and lengths of the boundaries are as follows :—

All the beacons are concrete pillars, all the bearings and lengths are approximate, and all bearings are referred to True North. (The Magnetic North at Bonny is 8° 13' West of True North).

DESCRIPTION—PARCEL "B"

All that parcel of land at Bonny in the Rivers Province containing an area of approximately 3,998.2 square yards in the area known as the Park, the boundaries of which are described as below :—

Starting at a temporary concrete pillar marked TBM2 which is 398.2 feet South and 440.3 feet East of a radio mast in front of the Decca Navigator's house, which is in the land belonging to Shell-BP D.P.Co. Limited, the boundaries run in straight lines and the bearings and lengths of the boundaries are as follows :—

All the beacons are concrete pillars, all the bearings and Lengths are approximate, and all bearings are referred to True North. (The Magnetic North at Bonny is 8° 13' West of True North.)

2. Any person claiming to have any right or interest in the said land is required within six weeks from the date of this notice to send to the Minister of Lagos Affairs care of the Permanent Secretary, Ministry of Town Planning (Land Division), Eastern Nigeria at his office in Enugu a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor-General is willing to treat for the acquisition of the said land.

4. Land in respect of which no statement is received is liable to be dealt with as unoccupied land.

5. And notice is also hereby given that the Governor-General intends to enter into possession of the land from the day following the publication of this notice.

6. Any person who shall wilfully hinder or obstruct the Governor-General or any person employed by him from taking possession of the said land is liable under the provisions of the Act above-mentioned on conviction to a fine of twenty-five pounds or to imprisonment for three months.
