

# Importation of Motor Vehicle—Issuing of Certificates of Payment of Duty and Certificates of Exemption from Duty prior to Registration/Licensing

In exercise of the powers conferred upon the Board of Customs and Excise under section 17 of the Customs and Excise Management Act (No. 55 of 1958), it is hereby notified for general information that every proprietor of or dealer in motor vehicles should be in possession of either of the Certificates mentioned hereunder as applicable as evidence that a particular vehicle has been subjected to the necessary Customs Formalities.

1. Certificate of Payment of Duty-Book C.50 (Appendix "A").—At the time of importation the Department of Customs and Excise will issue a Certificate of Payment of Duty on a Motor Vehicle in triplicate to the importer in respect of every motor vehicle on which duty has been paid. The importer or owner will submit the three copies to the Motor Registration/Licensing Authority with his application for a motor vehicle licence. One copy (triplicate) is to be returned to, and to remain in custody of, the licensee after endorsement.

2. Certificate of Exemption from Duty-Book C.51 (Appendix "B").—A certificate of Exemption from payment of Import Duty on a Motor Vehicle will also be issued in triplicate to a person or body of persons entitled to duty-free importation privileges. The certificate in triplicate will be surrendered to the Motor Registration/Licensing Authority with his application for a motor vehicle licence. One copy (triplicate) is to be returned to, and to remain in custody of, the licensee.

3. On issuing a licence to the owner, the Motor Licensing Authority will endorse and sign the Certificate of Issue of Licence on the reverse of the form, and forward the original to the Collector at the port or station of importation, retain the duplicate for reference purposes and hand over the third copy to the licensee.

4. Privileged Persons entitled to full Diplomatic Privileges.—Where a Privileged Person whose motor vehicle bears an FNCD plate intends to sell his car to a non-privileged person, he should first report the circumstances to the Customs. On payment of the duty on an assessed value, a Certificate of Payment of duty will be issued in the same manner and this must be produced by the new owner of the vehicle to the Licensing Authority and it is to be disposed of as in 3 above.

5. Privileged Persons not entitled to full Diplomatic Privileges.—Where a privileged person who is not entitled to full Diplomatic privileges and, therefore, whose motor vehicle bears no FNCD plate, desires to sell his car, he should first of all pay the duty on an assessed value agreed to by the Customs. A certificate of Duty Payment in triplicate will thereupon be issued wnich must be produced by the new owner of the yehicle to the Registration/Licensing Authority even though the vehicle had previously been registered under an ordinary number plate.

6. Where a privileged Body or Establishment entitled to import a motor vehicle free of duty disposes of the vehicle to a non-privileged person, the Certificate of Duty Payment will also be insisted upon by the Registration/Licensing Authority.

The qualifications prescribed for the Administrative and Special Departmental Classes are as follows:

(a) First or Second Class Honours Degree, preferably in Arts or Economics, from a recognised University.

(b) Third Class Honours or First or Second Class General Degree *plus* a Diploma in Public Administration from a recognised University.

(ii) Auditors and Accountants :

(a) Final Certificate of one of the following professional bodies :---

(i) Chartered Accountants

(ii) Society of Incorporated Accountants and Auditors

(iii) Association of Certified and Corporate Accountants

(iv) Institute of Cost and Works Accountants

(v) Institute of Municipal Treasurers and Accountants.

(b) Honours Degree in Economics or related subjects with Accountancy as a Special Subject from a recognised University.

For 1964, candidates in possession of any of the professional qualifications listed in (a) above will be exempt from the written examination.

. (iii) Management Officers and Assistant Registrars of Co-operative Societies:—First or Second Class Honours Degree in Economics from a recognised University.

(iv) Revenue Inspectors :

(i) Any of the accounting qualifications listed in sub-paragraph (ii) (a) and (b) above.

(ii) A degree in Law from a recognised University.

(iii) A call to the Bar.

(v) Produce Officers.—A degree in Agriculture, Commerce or Economics from a recognised University.

'Recognised' in the above contexts means "recognised by the Government of Eastern Nigeria".

4. The written examination will not be designed to test candidates on the subjects in which they hold a degree. It will be designed to test ability to think clearly and to understand and write English, and also of knowledge of affairs, particularly West African affairs. Notes for the guidance of candidates drawn up by the West African Examinations Council will be issued to all candidates in due course. The examination will comprise the following papers :—

(i) English (Precis and Critical Appreciation).— This paper will consist of a precis of a passage supplemented by a question asking candidates to comment critically on the central idea of the passage.

(ii) Current Affairs.—Candidates will be required to answer four questions out of ten and the range of subjects will cater for all types of candidates offering, and are designed to test the intelligent awareness of current affairs which any educated person may be presumed to possess.

(iii) General.—This will consist of two questions. One will test ability to detect dubious thinking, and will contain short passages whose Logical Force is to be discussed critically. The other will test ability to draw Statistical Inferences from a table of numerical data.

5. This written examination will be held on the 14th of April, 1964, in Lagos, Ibadan, Enugu, London, Washington or at such other centres as may be determined later. The dates and centres for the Departmental Service Boards will be announced later.

6. Minimum transport expenses to and from London and Washington will be refunded to candidates in the British Isles or the United States respectively who are not resident in those cities, for the purpose of taking the written examination. Candidates will be responsible for arranging and meeting the cost of their accomodation and transport.

7. A fee of  $\pounds 2$  is payable by those wishing to attempt the competition.

8. #### Constitution of the Federation

#### POLICE SERVICE COMMISSION (DELEGATION OF POWERS) NO. 2 NOTICE, 1963.

In exercise of the powers conferred by subsection (1) of section one hundred and ten of the Constitution of the Federation, the Police Service Commission of the Federation, with the approval of the Prime Minister, hereby makes the following delegation—

1.—(1) This delegation may be cited as the Police Service Commission (Delegation of Powers) No. 2 Notice, 1963.

(2) The provisions of this delegation, unless it is otherwise expressly provided or required by the context, shall apply in respect of members of the Nigeria Police Force below the rank of Assistant Superintendent and to posts in that Force in respect of which the initial basic salary does not exceed £726per annum or such other sum as may at any time be the initial basic salary of a Chief Inspector.

2.--(1) In this delegation--

"appointment" includes a temporary appointment and an appointment on probation, promotion, transfer or secondment, and includes the act of confirming any appointment;

"basic salary" means salary without contract addition or inducement allowance;

"initial basic salary" in relation to any post means the basic salary at the lowest point on the scale of salary applicable to such post.

(2) The definitions' contained in the Police Act shall apply to the construction of this delegation.

3.—(1) The Inspector-General may make appointments to any post to which this delegation applies subject to the condition that in respect of the post of Cadet Sub-Inspector the power shall be exercised with the prior approval of the Police Service Commission.

(2) A Commissioner of Police may make appointments to the rank of Sergeant-Major and below.

(3) A superior police officer of or above the rank of Senior Superintendent may make appointments to the rank of Constable and recruit Constable.

4.—(1) The Inspector-General may dismiss or terminate the appointment of any officer to whom this delegation applies subject to the condition that in respect of a Cadet Sub-Inspector the power shall be exercised with the prior approval of the Police Service Commission.

(2) A superior police officer shall have such powers to dismiss police officers or terminate the appointment of such officers as are or hereafter may be conferred upon him by regulations made under the Police Act.

5.—(1) The Inspector-General may exercise any disciplinary control (except surcharge) in respect of any police officer to whom this delegation applies subject to the condition that in respect of the interdiction of an officer above the rank of Cadet Sub-Inspector the power shall be exercised with the prior approval of the Police Service Commission. (2) Subject to the like condition, a superior police officer, and an Inspector authorised in writing in that behalf by a superior police officer in charge of a police province, shall respectively have such powers of disciplinary control (except surcharge) over police officers as are or hereafter may be conferred upon them by regulations made under the Police Act.

6. The Inspector-General in respect of any police officer, and a Commissioner of Police in respect of any police officer of lower rank where the act or default of a police officer results in the loss of government funds or the loss of or damage to government property, may respectively surcharge that police officer subject to the following conditions—

(a) the amount of the loss or damage in any one case shall not have exceeded £10;

(b) the amount of the surcharge shall be paid forthwith into the revenue of the Federal Government;

(c) except where the surcharge is imposed in respect of damage to a government quarter or loss of or damage to any furniture belonging thereto or loss of or damage to personal kit, a written report shall, following the surcharge, be furnished by, or through, the Inspector-General to the Director of Audit of the Federation and the Accountant-General of the Federation indicating the name of the officer surcharged and the circumstances and the amount of the loss or damage;

(d) where the loss or damage reveals a defect in the system of control of government funds or property, no surcharge shall be imposed until a written report containing recommendations for eliminating that defect has been furnished by, or through, the Inspector-General to the Police Service Commission, the Director of Audit of the Federation and the Accountant-General of the Federation.

7. Nothing in this delegation shall prevent the exercise by the Police Service Commission of any of the powers hereby delegated.

8. The Appointments and Discipline (Delegation) (Nigeria Police Force) Notice, 1959 (L.N. 123 of 1959) and the Police Service Commission (Delegation of Powers) Notice, 1963 (G.N. 1420 of 1963) are hereby revoked.
