In exercise of the powers conferred upon me by paragraph 1(1) of the Second Schedule to the Constitution of Mid-Western Nigeria and of all other powers enabling me in that behålf, I, NNAMDI AZIKIWE, President and Commander-in-Chief of the Federal Republic of Nigeria, do hereby appoint you the said CHIEF SAMUEI, JERETON MARIERE to be the Governor of Mid-Western Nigeria.

GIVEN under my hand and the Public Scal of the Federal Republic of Nigeria at State House, Lagos, this Seventh day of February, one thousand nine hundred and sixty-four.

APPOINTMENT OF DATE FOR HOLDING ELECTIONS INTO THE MID-WESTERN NIGERIA HOUSE OF ASSEMBLY IN THE URHOBO CENTRAL V CONSTITUENCY

It is hereby notified that in exercise of the powers conferred upon it by Regulation 17 of the Parliamentary Electoral Regulations, 1960, the Electoral Commission of the Federation has appointed Monday, the 9th of

March, 1964, as the date for holding an election into the House of-Assembly for Mid-Western Nigeria in the Urhobo Central V Constituency.
