APPOINTMENT OF MEMBERS OF THE ELECTORAL COMMISSION OF THE FEDERATION

In exercise of the powers conferred upon him by subsection (3) of Section 50 of the Constitution of the Federation, His Excellency the President has appointed

(1) DR JOSEPH ADEJUMOBI ADEGBITE
(representing the Western Region) and

(2) MR DAVID AKENZUA
(representing the Mid-Western Region)

to be members of the Electoral Commission of the Federation with effect from the 20th of February, 1964 and the 14th of March, 1964 respectively, and to hold office subject to the provisions of Section 50 aforesaid.

Other members of the Commission are

(1) ALHAJI MUHAMMADU BELLO
(representing the Northern Region) re-appointed with effect from the 11th of October, 1963 ;

(2) MR ANTHONY N. ANIAGOEU
(representing the Eastern Region) re-appointed with effect from the 11th of October, 1963 ; and

(3) REV. CANNON BENIAH ADELEKE ADELAJA
(representing Lagos) appointed with effect from the 14th of April, 1961.
