(i) the formula for the allocation of the proceeds of mining rents and royalties laid down in section 140 of the Constitution of the Federation;

(ii) the proportion of the proceeds of duties payable in respect of the import into Nigeria of any commodity other than motor spirit, diesel oil, tobacco, wine, potable spirits or beer, which is payable to the Distributable Pool Account; and

(iii) the formula for the distribution of funds in the Distributable Pool Account laid down in

Section 141 of the Constitution of the Federation;

(c) to take into account for the purpose of such examination—

(i) the experience of the various Governments of the Federation in the working of revenue allocation now in force;

(ii) the creation of the new Mid-Western Region and the proportion of the percentage of quarterly allocation payable to it under section 141 of the Constitution;

(iii) all sources of revenue and other receipts available or potentially available to each of the five Governments in the Federation; and

(iv) the legitimate requirements and responsibilities of each of the five Governments in the Federation;

(d) to consider the financial implications of the non-availability of promised foreign aid for university education and other unfulfilled pledges for financial assistance to Nigeria; and

(e) to make recommendations to the Federal Government on the above matters.
