Whereas by subsection (2) of section 122 of the Constitution of the Federation it is provided that the Judges of the High Court of Lagos shall be the Chief Justice of Lagos and such number of other Judges (not being less than five) as may be prescribed by Parliament.

AND WHEREAS it is provided by subsection (1) (as amended) of section 4 of the High Court of Lagos Act, Cap. 80 of the Laws of the Federation of Nigeria, that the number of Judges of the High Court of Lagos in addition to the Chief Justice shall be eight.

AND WHEREAS the number of Judges of the High Court of Lagos is now five in addition to the Chief Justice.

Now THEREFORE, I, NNAMDI AZIKIWE, President and Commander-in-Chief of the Federal Republic of Nigeria, in exercise of the powers conferred upon me by subsection (1) of section 123 of the Constitution of the Federation, do hereby, appoint BASIL AGBOLADE ADEDIPE to be a Judge of the High Court of Lagos with effect from the 1st day of September, 1964.

GIVEN under my hand and the Public Seal of the Federal Republic of Nigeria at State House; Lagos, this Seventh day of September, one thousand nine hundred and sixty-four.


