the Board may require the proprietor to obtain a report from the Federal Censorship Board appointed under section 3 of the Cinematograph Act 1963, No. 7. (d) In the case of advertising films, the films must :--

(i) relate to the products or equipment offered for sale or for hire by a person established outside Nigeria;

(ii) be of a kind suitable for exhibition to prospective customers and not for general exhibition to the

(iii) be imported in a packet which contains not more than one copy of each film and which does not form part of a larger consignment of films.

4. Refund of Duty or Release of Security .- A refund of such import duty deposited, or release of any security given in respect of films re-exported within the time allowed, shall be effected at the Custom House
