COMPULSORY ACQUISITION OF LAND

In exercise of the powers conferred upon the Lagos City Council by section 149 of the Lagos Local Government Act, 1959, Notice is hereby given that all those parcels of land (Parcels "A" and "B") at Faji Market in the City of Lagos, in the Federal Territory of Nigeria, comprising an area of approximately 1,498.98 sq. yards and 580.23 sq. yards respectively, the boundaries of which are more particularly described below are required for Local Government purposes by the Lagos City Council and the Minister of Lagos Affairs has given his consent to the acquisition.

Parcel "A" comprising an area of 1498.98 sq. yards.

In exercise of the powers conferred upon the Lagos City Council by section 149 of the Lagos Local Government Act, 1959, notice is hereby given that all that parcel of land at Igbobi, in the City of Lagos, in the Federal Territory of Nigeria, comprising an area of approximately 4.064 acres, the boundaries of which are more particularly described below, is required for Local Government purposes by the Lagos City Council and the Minister of Lagos Affairs has given his consent to the acquisition.
