REBATE ON STUDENTS AIR PASSAGE

This period is from 1st of June to 30th September.

4. Students are also warned against the activities of some unscrupulous Travel Agents who elect to book students' passage for them. Experience of the past years has revealed that some students have had their flights deferred to the embarrassment of those students and their relations because Travel Agents failed to book their passage according to the schedule. It will, therefore, be in their interest if students collect the rebate forms themselves and book their passage direct with the Nigeria Airways.
