Police Service Commission (Delegation of Powers) (Nigeria Special Constabulary) Notice 1966

Commencement: 2nd June 1966

In excercise of the powers conferred by section 110 (1) of the Constitution of the Republic, the Police Service Commission of the Republic, with the approval of the Head of the National Military Government hereby makes the following delegation-

1. This delegation may be cited as the Police Service Commission (Delegation of Powers) (Nigeria Special Constabulary) Notice-1966.

Citation.

2. Except where the context otherwise requires, expressions used in this delegation have the same meaning as in the Special Constables Decree 1966.

Interpretation.

3. This delegation shall apply in respect of appointments of and disciplinary control over special constables of or below the rank of chief superintendent save that in the case of a special constable who is an officer in the public service of the Republic this delegation shall only apply in respect of his service as a special constable.

Application.

4.—(1) The power to appoint special constables is hereby delegated to— (a) the Inspector-General in respect of appointments up to and including the rank of chief superintendent;

Power to appoint.

(b) a commissioner of police in respect of appointments up to and including the rank of inspector;

(c) a chief superintendent of police (being a regular police officer) in

respect of appointments up to and including the rank of sergeant;

(d) the superior police officer in charge of a police province or police division in respect of appointments up to and including the rank of corporal.

(2) The power to make an appointment to any rank includes the power to promote to that rank, to suspend that appointment and to determine it and further includes the power to give consent is espect of that appointment, to a resignation notice given under section 3 in of the Special Constables Decree.

(3) Any power conferred on a police officer of a particular rank may be

exercised by a police officer of a higher rank.

- (4) Without prejudice to the foregoing provisions of this paragraph, there are hereby delegated to superior police officers in charge of police areas and to chief superintendents of police all such powers of appointing and determining the appointments of emergency special constables as are, subject to section 5 (3) of the Special Constables Decree 1966, conferred on them by section 4 of that Decree.
- 5. Power to exercise disciplinary control over special constables is delegated in accordance with the Schedule of this delegation.

Disciplinary Power.

6. The Inspector-General in the case of any special constable, and a Power to commissioner of police in the case of a special constable of the rank of, Surcharge. inspector or below, may impose a surcharge on a special constable where' an act of the special constable results in the loss of government funds or loss of or damage to government property and the amount of the loss or damage does not in any one case exceed ten pounds.

Submission of Report.

7. Any amount of surcharge recovered in pursuance of paragraph 6 above shall forthwith be paid into the revenue of the Republic and except where the surcharge is imposed in respect of loss of or damage to personal kit, a written report shall, following the surcharge, be furnished by or through the Inspector-General to the Director of Audit of the Republic and the Accountant-General of the Republic indicating the name of the special constable surcharged and the circumstances and the amount of the loss or damage.

Report to be submitted.

8. Where a loss or damage in respect of which a surcharge is liable to be imposed in pursuance of paragraph 6 above reveals a defect in the system of control of government funds or property, no surcharge shall be imposed until a written report containing recommendations for eliminating that defect has been furnished by or through the Inspector-General to the Police Service Commission, the Director of Audit of the Republic and the Accountant-General of the Republic.

Police Service Commission can exercise Powers delegated.

9. Nothing in this delegation shall prevent the exercise by the Police Service Commission of any of the powers hereby delegated.

Revocation of L.N. 263 of 1959.

10. The Appointments and Discipline (Delegation) (Nigèria Special Constabulary) Notice 1959 is hereby revoked.
