WHEREAS each of the persons whose names are set out in column 1 of the Schedule hereto having been duly convicted of the offence or offences stated against his name in column 2 of the Schedule and sentenced to the term of imprisonment stated in column 3 of the said Schedule :

AND WHEREAS each of the said persons having served a portion of the sentence originally imposed on him on the date mentioned in column 4 of the Schedule :

AND WHEREAS the Supreme Military Council after reviewing his case, is pleased to remit his sentence and to grant him a full pardon :

NOW THEREFORE, in exercise of the powers conferred by section 101 (1) of the Constitution of the Republic and of all other powers enabling it in that behalf, the Supreme Military Council do hereby remit the unexpired portion of the sentence imposed on each of the aforesaid persons and grant each and everyone of them a full pardon.

AND WHEREAS the Supreme Military Council after reviewing his case, is pleased to remit his sentence and to grant him a full pardon :

NOW THEREFORE, in exercise of the powers conferred by section 101 (1) of the Constitution of the Republic and of all other powers enabling it in that behalf, the Supreme Military Council do hereby remit the unexpired portion of the sentence imposed on each of the aforesaid persons and grant each and everyone of them a full pardon.
