INSTRUMENT OF FULL PARDON

THE CONSTITUTION OF THE FEDERATION

AS MODIFIED BY THE CONSTITUTION (SUSPENSION AND MODIFICATION) DECREE 1966

WHEREAS CHARLES OLAYINKA ADESANYA, having been duly convicted of the offences of conspiracy to defraud, conspiracy to commit a felony and forgery, and sentenced to a fine of £50 or imprisonment for four months on all three counts ;

AND WHEREAS the said CHARLES OLAYINKA ADESANYA having paid the fines originally imposed on him in March 1963;

AND WHEREAS the Supreme Military Council, after reviewing his case, is pleased to grant him a full pardon.

NOW THEREFORE, in exercise of the powers conferred by section 101 (1) of the Constitution of the Federation and of all other powers enabling it in that behalf, the Supreme Military Council do hereby grant CHARLES OLAYINKA ADESANYA a full pardon.

GIVEN UNDER my hand and the Public Seal of the Federal Republic of Nigeria at Lagos, this 8th day of November, one thousand nine hundred and sixty-seven.
