

THE APPROPRIATION DECREE 1970



Decree No. 35

THE FEDERAL MILITARY GOVERNMENT hereby decrees as follows :—

1.—(1) The Accountant-General may, when authorised so to do by warrants signed by the Federal Commissioner for Finance pay out of the Consolidated Revenue Fund of the Federation during the year ending 31st March 1971 the sum specified by the warrants, not exceeding in the aggregate two hundred and sixty-seven million, nine hundred and twenty thousand and eight hundred and fourteen pounds.

(2) The amount mentioned in the foregoing subsection shall be appropriated to heads of expenditure as indicated in the Schedule to this Decree.

(3) No part of the amount aforesaid shall be issued out of the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.

2.—(1) This Decree may be cited as the Appropriation Decree 1970 and shall apply throughout the Federation.
