In a few cases, however, the old series of registration numbers allotted to the former Regional Governments and the Federal Government have been retained.

- Employers and workers who have already been registered under the National Provident Fund Scheme are not required by this publication to seek a fresh registration. An unregistered employer is however required, as soon as he becomes subject to the National Provident Fund Act, to get himself registered with the Fund as an employer. The Director on his part will allot an employer's registration number to the employer and notify him accordingly in the prescribed Form NPF. 12. The employer immediately after his registration, will complete and forward to the Director prescribed Form NPF. 13 in respect of each of his workers, unless the worker produces evidence that he is already a member of the Fund. The Director will then register the workers, allot to them registration numbers and immediately forward for delivery to them, certificates of membership on the prescribed Form NPF. 14.
