The Director will then register the workers, allot to them registration numbers and immediately forward for delivery to them, certificates of membership on the prescribed Form NPF. 14.

(i) Systems analysis, program design, coding and the actual programming work of the Fund;

(ii) Maintenance of all necessary information, record, files, cards, discs or tape connected with his work;

(iii) Handling of all operational and other related problems which may arise from time to time in the data processing work of the Fund.

4. **Conditions of service.**—The post is pensionable and in the case of a new entrant into Government Service the appointment will be on probation for three years. Appointment may, however, be on contract basis. The successful applicant may, if necessary, be sent overseas for further training and attachment in order to acquaint him with the latest development in the field of computerization as it concerns the work of the National Provident Fund.

5. **Qualifications.**—Candidates should have—

(i) a good general education and several years' experience of data processing involving the use of punch cards and associated equipment coupled with considerable experience of system analysis and programmings;

(ii) experience in the organisation and running of a medium size computer machine installation.
