## THE CONSTITUTION OF THE FORMER NORTHERN NIGERIA

AS MODIFIED BY THE CONSTITUTION (SUSPENSION AND MODIFICATION) DECREE 1966 AND THE STATES (CREATION AND TRANSITIONAL PROVISIONS) DECREE 1967

WHEREAS by section 50 (2) of the Constitution of the former Northern Nigeria as modified by the Constitution (Suspension and Modification) Decree 1966, the States (Creation and Transitional Provisions) Decree 1967 and the Constitution (Northern States) (Amendment) Decree 1969 it is provided that the Judges of the High Court of each of the States created out of former Northern Nigeria shall be the Chief Justice and such number of other Judges (not being less than two) as may be prescribed by law :

AND WHEREAS by section 51 (6) of the said Constitution of the former Northern Nigeria modified as aforesaid it is provided that if the office of any Judge of the High Court other than the Chief Justice is vacant or if the person holding the office is acting as Chief Justice or is for any reason unable to perform the functions of his office, the Supreme Military Council, acting after consultation with the Advisory Judicial Committee, may appoint a person with such qualifications as may be prescribed by law to act in the office of a Judge of the High Court :

NOW THEREFORE, THE SUPREME MILITARY COUNCIL, acting after consultation with the Advisory Judicial Committee, do hereby appoint SHEHU USMAN MOHAMMED to act as a Judge of the High Court of Kwara State and of the High Court of North-Central State with effect from 29th June 1970.

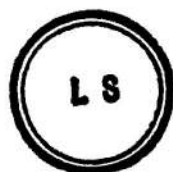

All that strip of land approximately 200 feet wide on the Ocean Bottom starting at the Ubit "D" Well Platform whose Nigerian Co-ordinates are N 30,255 metres; E 634,630 metres and whose Greenwich Coordinates are N 04° 16' 25"; E 08° 10' 35" and extending on an approximate bearing of S 57° 33' W for a distance of approximately 0.76 miles to the Ubit Production Platform whose Nigerian Coordinates are N 29,600 metres; E 633,600 metres and whose Greenwich Co-ordinates are N 04° 16' 04"; E 08° 10' 01". The beginning of the pipeline at the Ubit "D" Well Platform will be in approximately 88 feet of water. The termination of the pipeline at the Ubit Production Platform will be in approximately 85 feet of water.

2. A copy of the plan of the pipeline route identifying the sea bed and the land affected may be inspected at the Ministry of Agriculture and Natural Resources, Calabar, the Federal Ministry of Mines and Power, Lagos, and Port Harcourt and the office at the New Niger House, 1-5 Odunlami Street, Lagos of the aforesaid Company.

3. Any person who considers that his interest or interests will be injuriously affected by the grant of the Licence should lodge orally or in writing, not less than seven (7) days before the hearing date in paragraph 6, with the Ministry of Agriculture and Natural Resources, Calabar, Notice of objection stating the interest of the objector and the grounds of objection.

4. Any Public Officer who receives a verbal objection in the course of his duties shall record the name and address, interest and grounds of objection of any person lodging such a verbal objection and shall forward the details to the Ministry of Agriculture and Natural Resources, Calabar.

5. Matters relating to the amount of compensation payable by the aforesaid Company for the use of the sea bed and land affected shall not be material grounds to include in a notice of objection.

6. The Delegate of the Ministry of Agriculture and Natural Resources, Calabar shall inquire into objections (if any) duly lodged in accordance with paragraphs 3 and 4 above at the office at Calabar at 10 a.m. on the 11th day of September, 1970 giving all parties an opportunity to be heard, and reports thereof shall be sent without delay to the Chief Petroleum Engineer, Federal Ministry of Mines and Power, Lagos.

7. Compensation (if any) payable by the aforesaid Company for the use of the sea bed and land affected shall be determined by negotiations between the Company and those whose interest or interests are affected.
