3. *Background and functions.*—The education programme for the Arab refugees from Palestine is sponsored jointly by Unesco and the United Nations Relief and Works Agency (UNRWA). There are some 480 schools for refugee children in the four host countries with a total enrolment of over 226,000 and a teaching staff of nearly 6,270.

The teachers employed in these schools are themselves Palestinian refugees. In addition there are 5 UNRWA/Unesco Teacher Training Institutes in operation, two of them in the West Bank of Jordan and 2 in East Bank and 1 in Lebanon; and 6 Vocational Training Centres, 2 in the West Bank of Jordan and 1 in the East Bank of Jordan, Lebanon, Syria and the Gaza Strip. These TT Institutes prepare teachers to teach in the primary cycle.

The UNRWA/Unesco Institute of Education runs a programme of in-service training for insufficiently qualified teachers using a synthesis of indirect instruction through correspondence courses and the use of audio-visual media, and of direct help and guidance in the form of weekly seminars, vacation courses and individual tutorship given to the teacher trainees by the Institute's field staff of twenty Field Representatives.

Under the general supervision of the Director of the UNRWA/Unesco Department of Education, the incumbent will be responsible for the improvement of the teaching of mathematics in both the schools and the training centres.

In particular he will :

(a) *Pre-service education :*

(i) plan, and revise the mathematics syllabus of Teacher Training centres ;

(ii) select reference books, teaching and learning aids which help train students in modern and effective methods of teaching mathematics ;

(iii) guide and supervise the work of mathematics instructors in the TT Centre ;

(iv) supervise the training of student teachers in the practice schools ;

(v) contribute to research and experimental work in mathematics teaching ;

(b) *In-service education.*—Collaborate with the UNRWA/Unesco Institute of Education in the in-service training of elementary and preparatory school teachers, through the development of programmes of the various courses, the development of the study materials, the selection of teaching and learning aids and the encouragement of methods which develop thinking and problem-solving attitudes;

(c) *School education.*—Improve through Subject Supervisors of Mathematic methods of teaching of mathematics in the primary and preparatory schools, and introduce the teaching of new mathematics;

(d) *Unesco Project.*—Participate in the Unesco Mathematics Project for the Arab States and apply the new trends and the new ideas propagated by the Project in all UNRWA fields;

(e) *Staff Training:*

(i) guide and supervise the work of Associate Mathematics Specialists attached to the Department of Education;

By 1968, the number of primary schools has risen to the total of 153 (127 government and 26 mission schools) with approximately 25,000 pupils and 39 intermediate schools with over 6,000 students. There are 3 government and 3 mission secondary schools for the age range of 16-20, the graduates of which take the New Zealand School Certificate Examination. A Teacher Training College provides training for all primary school teachers, while secondary and some intermediate school teachers are trained abroad.

Unesco assisted the country with the aid of UNDP and UNICEF in the field of science education since 1965 and the project will come to completion at the end of 1970. The project has introduced new school science curriculum and the in-service training of science teachers in the new curriculum has also been undertaken. The University of South Pacific in Fiji, being assisted by Unesco and UNDP, will follow up the continued technical assistance to the curriculum development work.
