IN THE MATTER OF SECTION 4 (2) OF THE TRADE DISPUTES (EMERGENCY PROVISIONS)  
(AMENDMENT) DECREE NO. 53 OF 1969

and

IN THE MATTER OF A TRADE DISPUTE BETWEEN THE NIGERIAN PORTS AUTHORITY  
CLERICAL WORKERS' UNION AND THE NIGERIAN PORTS AUTHORITY

WHEREAS a Trade Dispute has arisen and now exists between the Nigerian Ports Authority Clerical Workers' Union and the Nigerian Ports Authority ;

AND WHEREAS the endeavour to promote a settlement by getting the parties to meet over the points in dispute have proved unsuccessful ;

NOW THEREFORE, THE COMMISSIONER FOR LABOUR, in exercise of the powers conferred upon him by section 4 (2) of the Trade Disputes (Emergency Provisions) (Amendment) Decree No. 53 of 1969, hereby refer the matters in dispute to the Industrial Arbitration Tribunal with the following terms of reference :—

"To inquire into the trade dispute declared by the Nigerian Ports Authority Clerical Workers' Union against the Nigerian Ports Authority in accordance with section 4 (1) of the Trade Disputes (Emergency Provisions) (Amendment) Decree No. 53 of 1969 over the following issues :—

1. Breach of Agreement in respect of absorption of female Development Assistants into the Permanent Establishment as Secretary-Typists ;
2. The case of Chief Clerks who have been acting as Assistant Establishment Officers since 1967 and 1968 ;
3. The case of Miss Ayanbule and others—Shorthand-Typists ;
4. The case of Secretary-Typists—Messrs Odubonjo Thanni and others ;
5. Creation of the posts of Personal Secretary, Grade II ;
6. Payment of Overtime to all Clerks who work in excess of 39 hours a week ;
7. Filling of the posts of Head Messengers and Head Cleaners ;
8. Creation of the posts of Chief Hall Porter and Senior Hall Porter ;
9. Creation of the post of Telephone Supervisor on Assistant Chief Clerk Grade ;
10. Appointment of Copy Typists ;
11. Acting appointments—Secretarial Staff ;
12. Promotion of Staff—Personal Secretary Grade, etc., etc. ;
13. Grading of Radio/Telephone Mechanics—Promotional Avenues for them ;
14. The cases of



## NOTICE BY THE BOARD OF CUSTOMS AND EXCISE

Customs and Excise Notice No. 56

CUSTOMS AND EXCISE BONDS  
Commencement: 1st April, 1971

NOTE: (i) Bond forms mentioned in this Notice are obtainable from the proper officer at any Custom House.

(ii) Specimens of these forms are at Annexe "C" to "V" and are not to be printed privately.

1. *Law.*—The law relating to Customs and Excise Bonds and other securities is contained in section 128 of the Customs and Excise Management Act No. 55 of 1958.

2. *Definitions:*

(a) "Bond" is a legal instrument by which persons entering into it bind themselves to pay to the Board of Customs and Excise a specified sum of money on the breach of any of the conditions mentioned therein.

(b) "Principal" refers to the person undertaking the transaction for which the bond is required.

(c) "Surety" means the person who undertakes to discharge the liabilities of the principal in case of default; and for the purpose of this notice, the surety is deemed to be a principal debtor.

3. *Bonds acceptable to the Board.*—For the purpose of customs and excise laws, the bonds acceptable to the Board are the bonds listed in Annex A and any other bonds which the Board may from time to time by notice further specify.

4. *Sureties acceptable to the Board.*—Only Banks and Insurance Companies approved by the Board, as listed in Annex 'B' are acceptable as sureties for Customs and Excise bonds. The list will be amended from time to time.

5. *Execution of Bond:*

(a) A bond must be executed by the principal and a surety which must be an approved Bank or Insurance Company.

(b) Both the principal and the surety must each sign the bond in the presence of a witness.

(c) Where the principal is a company registered under the Company Decree of 1968, the bond must be signed by a director, secretary or an authorised responsible officer.

(d) Where a person other than a director, or a secretary is to sign the bond, on behalf of a company, the Board may require such person to produce its authority so to do.

(e) The common seals of the principal, if a company, and the surety must be affixed to the bond.

(f) In the case of a firm, the bond must be executed in the names of the partners of the firm and sealed.

(g) Bonds must not be defaced, mutilated or pierced with pins.

(h) All alterations on a bond made before execution must be fully signed by the signatories to the bond. No alterations are permitted after execution.

6. *Bonds returned by Post.*—A bond duly executed and despatched to the Board by post shall be deemed operative only from the date of acceptance of the bond by the proper officer and communicated in a letter to the parties who executed the bond.

7. *Rejection of Bond.*—Any bond which is not properly completed shall be rejected.

8. *Cancellation of Bonds:*

(a) Bonds will not be cancelled on the instruction of either the principal or the surety without the consent of the Board and such consent shall not be given until all the obligations thereunder have been fully performed.

(b) Written advice will be issued to principals and sureties when Bonds are cancelled but the cancelled Bonds will be retained by the Board.

9. *Security other than Bond.*—The Board may require any person to give security in cash equivalent to the amount for which a bond shall have been taken. Such cash security is refundable on performance of the conditions specified by the Board at the time of making the cash deposit otherwise the bond shall be forfeited.

WESTERN NIGERIA MARKETING BOARD  
APPOINTMENT OF LICENSED BUYING AGENTS  
FOR THE 1971-72 COCOA SEASON

It is notified for general information that the Board is prepared to consider applications for appointment as licensed buying agents for the 1971-72 Cocoa Season which will open about September 1971. The exact date will be notified later by publication in the *Western Nigeria Gazette*.

2. Applicants will be required to produce evidence that they are likely to be able to fulfil the minimum conditions set out in the following paragraphs, which are based on:—

(a) the normal functions which a licensed buying agent is required to perform;

(b) ability to purchase and handle a minimum of 400 tons for an average season;

(c) stipulated conditions as regards storage, evacuation, etc.

3. *Functions of licensed buying agents.*—The main functions which licensed buying agents will be required to perform on behalf of the Board are:—

(a) to purchase cocoa at gazetted buying stations at not less than the minimum prices;

(b) to bag and arrange for inspection in accordance with the regulations;

(c) to finance purchases and provide suitable storage until the time of evacuation to port;

(d) to make returns of purchases and stocks as the Board or its duly authorised executive may require;

(e) to arrange for conveyance and delivery of cocoa to Board's stores, Ikeja and Apapa and according to instructions which may be issued from time to time by the Board's executive.

*Minimum conditions.*—(a) *Purchases.*—Applicants must produce evidence of ability to purchase with reasonable regularity throughout a season a minimum of 400 tons of cocoa (i.e. Main and Light Crops inclusive). Evidence will be required of previous experience in the produce trade and of the established firms of licensed buying agents to which the applicant had been selling his purchases. In this connection, applicants may be required to produce their previous purchases and sales records and/or certificates from licensed buying agents of purchases sold to them in previous seasons.

(b) *Capital.*—The minimum capital requirement necessary to fulfil the obligations of a licensed buying agent as at (a) above has been fixed by the Board as £9,000. Applicants will be required to forward, as evidence of their ability to satisfy this minimum requirement, copies of their bank statements for the six months preceding the date of the application, duly certified by their bankers. Only applications to which such bank statements have been attached will be considered.

(c) *Storage and twine.*—Applicants must be able to provide evidence that they have available in their proposed areas of operation proper storage for at least two hundred tons of cocoa. All stores must comply with the requirement of, and be approved by the Western Nigeria Produce Inspection Service. It is the responsibility of the applicant to request, in writing, the Produce Officer of the area concerned

to inspect and approve his stores. Applicants will be required to produce evidence of ability to provide sufficient twine to cover at least the minimum purchase requirement.

(d) *General.*—Applicants must be prepared to produce satisfactory evidence to show that they are fully conversant with the cocoa trade and likely to be able to fulfil the following conditions:—

(i) *Inspection of Cocoa.*—That they will be able to provide an adequate labour force at all stores to handle cocoa at the time of inspection.

(ii) *Returns.*—That they will render promptly and accurately all returns, particularly of purchases and stocks, which may be called for.

(iii) *Evacuation.*—(a) That they will be able to make arrangement to secure the necessary transport to ensure the smooth and regular evacuation of cocoa by approved routes.

(b) That they possess the necessary organisation at port or the ability to secure reliable agents to ensure the carrying out of all duties involved in the delivery of cocoa to Board's stores.

5. *Method of application.*—Application forms and details as to their completion can be obtained free of charge from the Headquarters of the Western Nigeria Marketing Board, Cocoa House, Bank Road, Ibadan or the Lagos Zonal Headquarters of the Board, Private Mail Bag 1018, Ikeja Industrial Estates, Ikeja.

6.
