RESPONSIBILITY
UNDER THE QUARRIES DECREE 1969
(Decree No. 26 of 1969)

The attention of all quarry owners is hereby drawn to Regulation 27 (1) of the Quarries Regulations 1969 which makes Parts 1-V and Parts X, XI, XII and XIV of the Safe Mining Regulations under Cap. 121 of the Minerals Act applicable to Quarries. Attention is also drawn to Regulation 27 (2) which makes some of the provisions dealing with mining operations generally, also applicable to Quarries.

2. All quarry owners shall, with immediate effect make the following appointments for the purpose of supervising their quarrying operations:—

(a) In the case of quarries producing 10 cubic yards or less of stones, sand, gravel, etc. per day an overseer as required by Safe Mining Regulation 134 (2) should be appointed and the Area Inspector of Mines incharge of the area notified;

(b) In the case of quarries producing over 10 cubic yards of stones, sand, gravel, etc. where machinery such as compressors and excavators are not in use, an overseer under Safe Mining

Regulation 134 (2) or, if so advised by an Inspector, a manager under Safe Mining Regulation 134 (1);

(c) In the case of quarries producing over 10 cubic yards per day and using machinery such as compressors, excavators, crushing and screening plants, a manager under Safe Mining Regulation 134 (1).

3. For the purpose of this notice, a manager means the person who, in the opinion of the Chief Inspector of Mines, possesses either adequate mining or quarrying experience or qualification in mining or quarrying and who is registered under the Safe Mining Regulations as responsible for the work, safety, welfare, health and housing conditions of persons employed in mining or quarrying operations and when no such person has been so registered, it shall mean the holder or lessee or his lawful attorney. A copy of the power of Attorney and any alterations thereof, shall be sent to the Chief Inspector of Mines, Federal Ministry of Mines and Power, Mines Division, Private Mail Bag 12574, Lagos.
