ESTABLISHMENT OF PLANTS FOR THE PRODUCTION OF EDIBLE SALT

The Federal Government desires to establish, in collaboration with any local or foreign investor, Government or International Institution two plants for the production of edible salt based on the importation of crude salt for local refinery at two major ports, each with a maximum tonnage of 75,000 tons per annum under the following terms:—

(a) That the proposals should be economically viable and that price policies should be such as to maintain a stable price for salt during a specified period;

(b) That Government participation in equity shall not exceed 55 per cent of the equity shares in both plants;

(c) That the equity participation of the prospective investors, who will also be technical partners, will not be less than 40 per cent of the equity shares in both plants;

(d) That the prospective partners should be capable of providing efficient management of the manufacturing plants and distribution system;

(e) That there should be provision for stockpiling of crude salt for at least one year in peace time and at least two years in war time;

(f) That a detailed training scheme for Nigerians will be designed by the prospective partners to ensure that the Nigerians acquire suitable know-how to operate the industry within a reasonable period;

(g) That the industry should be flexible enough to utilise local sources of raw materials when available in commercial quantities;

(h) That there should be provision in the proposals for the eventual manufacture of by-products, such as industrial salt, caustic soda, chlorine, etc.;

(i) That the proposals submitted should not be based on a turn-key system;

(j) That no preference should be given to any one currency area;

(k) That the salt to be produced should either be light or high density salt.

2. All applications already submitted should be revised along the terms set out in this Notice and re-submitted. Revised as well as fresh proposals should be marked "Secret" and forwarded to the Permanent Secretary, Federal Ministry of Industries, Yakubu Gowon Street, Lagos, not later than 30th September, 1971. All proposals received will be evaluated in accordance with the normal Government procedure.
