"To inquire into the trade dispute declared by the South-Eastern State Agricultural Development Corporation and Allied Workers' Union against the Management of the South-Eastern State Agricultural Development Corporation in accordance with section 4 (1) of the Trade Disputes (Emergency Provisions) (Amendment) Decree No. 53 of 1969 over the following issues:—

(i) The Union contends that category 'B' of the Corporation salary structure is in respect of its employees who are supervisors and as such should be placed on the same scale as category 'A' above. The management maintains that the employees concerned are non-supervisory staff and as such they are within Class V of the Ani's recommendation whose scale of salary is £500-950. Management is prepared to pay this scale but it is not acceptable to the Union.

(ii) Union contends that First Class Clerks of the Corporation should be placed on the scale of £420-570 on the ground that this is the scale appropriate to them under Class V of the recommended scales of Ani. The management contends that First Class Clerks come under Class VI of the Ani's recommended scale with the salary range of £160-500 for all Clerical Employees. That the Corporation has brought First Class Clerks within the salary range by making them run the scale of £388-500.

(iii) The Union contends that Third Class Clerks and Accounts Clerks, Grade III in the Corporation should be made to go up to the maximum of £500 under Class VI of the Ani's recommended scale instead of the Management fixing their maximum at £288;

and to make such awards, having regard to the circumstances of the dispute, and such other matters pertaining thereto or arising therefrom as the Industrial Arbitration Tribunal may deem necessary."
