Corporations Standing Tenders Board Decree 1968 (1968 No. 54)

APPOINTMENT OF CHAIRMAN AND MEMBERS OF THE CORPORATIONS STANDING TENDERS BOARD

1. MEDICAL LABORATORY TECHNICIAN:

Salary scale.—E1 (B and C) 3 (£258-508).

(i) *Qualification.*—Applicants should possess any of the following qualifications:

(a) West African School Certificate with credits in English Language, Elementary Mathematics, Chemistry, either Biology or Physics, and one other subject; or

(b) General Certificate of Education Ordinary Level with passes in subjects (a) above.

(ii) *Age.*—Applicants must not be above 25 years.

(iii) *Duties after training.*—To carry out routine pathological examinations of specimens in hospital laboratories.

(iv) *Training and duration.*—Successful applicants will be trained for three years in either the Federal School of Medical Laboratory Technology, Lagos, the Lagos University Teaching Hospital, or the University College Hospital, Ibadan, as Medical Laboratory Technicians. Laboratory Technicians will sit for the intermediate examination of the Institute of Medical Laboratory Technology at the end of the period of training. Successful candidates will be eligible for consideration for promotion to the grade of Assistant Laboratory Technologist.

2. X-RAY TECHNICIAN:

Salary scale E1 (B and C) 3:

(i) *Qualification.*—Applicants should possess any of the following qualifications:

(a) West African School Certificate with credits in English Language, Elementary Mathematics, two Science subjects preferably Physics and Biology or their equivalents, or

(b) General Certificate of Education, Ordinary Level, with passes in subjects in (a) above.

(ii) *Age.*—Applicants must not be above 25 years.

(iii) *Duties after training.*—To carry out diagnostic radiographic investigations.

(iv) *Training and duration.*—Successful applicants will be trained in the University College Hospital, Ibadan, or the Federal School of Radiography, General Hospital, Lagos, for three years. An X-Ray Technician who obtains Membership of the Society of Radiographers or an equivalent qualification will be eligible for promotion to the grade of Radiographer.

Country.—Indonesia.

Project.—UNDP/INS/72xxx/P.3.

Date issued.—June 1972.

General field.—Co-operative Training and Development.

Title of post.—225—Expert in Co-operative Credit and Finance (Post No. 3).

Duty station.—Djakarta.

Duration of appointment.—12 months, with possibility of extension up to a total of 14 months.

Desirable starting date.—November 1972.

Terms of appointment.—Salary and allowances are free from income tax. Although quoted in US dollars, they are payable partly in the currency of the home country and partly in the currency of the duty station.

Annual salary.—Between US \$13,578 and US \$17,568.

(The initial salary of the appointee will be fixed in accordance with his/her qualifications and experience. Increments are granted annually.)

Post adjustment.—(Class 4) (subject to change) between US \$1,584 and US \$1,984 (single rate), between US \$2,376 and US \$2,976 (dependant rate).

Assignment allowance.—US \$950 (single rate) US \$1,200 (dependant rate).

Family allowance (if eligible).—Spouse: US \$400 per annum. Each child: US \$300 per annum.

Other benefits.—Installation allowance, education grant for children, repatriation grant upon termination of assignment, 30 working days' annual leave, home leave travel with eligible dependants every 2 years, social security benefits.

Description of duties.—The expert will, as a member of a team of ILO experts, advise and assist the Government of Indonesia in matters relating to the development of a rural credit system on co-operative lines. In this connection the expert will:

advise and assist the Directorate-General of Co-operatives in the organisation of viable rural thrift and credit co-operatives;

prepare a training programme or programmes and direct training courses for staff and members of such co-operatives;

provide specialised training for officials of the Directorate-General of Co-operatives engaged in promotion and development of rural thrift and credit co-operatives.

Background.—During the last five years the co-operative movement in Indonesia has undergone reorganisation. A new co-operative law was enacted in 1967; many defunct co-operatives have been dissolved. About 17,000 primary co-operatives exist (end 1971) grouped into unions/federations at provincial and national levels.

The Directorate-General of Co-operatives which has been established in the Department of Transmigration and Co-operatives is responsible for the implementation of the Government's co-operative policy and will act as Government Co-operating Agency for this project. The Directorate-General has a considerable budget for its activities and is adequately staffed. Main emphasis in its work is given to the development of appropriate training programmes for Co-operative members, staff and directors and for officials of the Directorate-General of Co-operatives. Co-operative training centres have been established in Djakarta and several provinces, but there is a lack of qualified teachers and instructors and of education and training material. There is also a need for developing appropriate curricula and course outlines for the use in the existing training facilities.

The immediate objectives of the project are to assist and advise in planning and implementing

programmes for co-operative training and education, developing training material and audio-visual aids, establishing syllabi and course outlines in co-operative organisation and management, and training instructors in these fields. Training will be given also to officials of the Directorate-General of Co-operatives and to managers, staff and members of co-operative societies at primary, secondary and apex levels. The project will also assist in establishing standards and systems for the improvement of co-operative management and accountancy and in developing co-operative credit institutions and rural banks.

Qualifications required.—Good knowledge of co-operative principles and practice.

Extensive experience in the organisation and management of rural co-operative credit, preferably in primary and secondary co-operatives, in developing countries.

Ability to train both instructors and co-operative staff in these fields.

Teaching experience would be of advantage.

Language.—English.
