CHAIRMAN'S REPORT

It gives me great pleasure to be privileged to present the first Accounts of the National Insurance Corporation of Nigeria covering the period of 18 months from 1st July, 1969 to the 31st December, 1970. As you are aware, this Corporation was established in 1969 by Decree No. 22 and on the 1st July that year it commenced business. It started slowly, and gradually took over during the 18 months period the whole insurances of all Statutory Corporations and most Government and quasi-Government bodies. By the end of 1970 it had also successfully set up an effective administration for dealing with the 10% cessions compulsorily reinsured with this Corporation under the provisions of section 8 of the Decree. There were inevitably teething troubles. We did not in the early days have an effective Management but by the end of the period under review, most of these problems were resolved. This Board of Directors of the Corporation was appointed in 1970 and the Corporation had appointed an expatriate Managing Director and a Management team under him.

I will turn now to a brief commentary on the individual underwriting sections of the accounts.

FIRE INSURANCE ACCOUNT

This account is small and, of course, does not include compulsory cessions which did not enter into our operations until the 1st of January, 1971. We have restricted our net retentions under the Fire Account in accordance with recognised Fire Insurance practice as we feel that the account must not be exposed to high risk potential in the early years of its life. As our capacity increases by growth in income and by the increase in the Fire Departmental fund so will net retentions increase. It is very pleasing to record a profit of over £54,000 based primarily on commission earnings.

MOTOR INSURANCE ACCOUNT

As it will be seen the Corporation made a trading loss of some £19,000. This is not exceptional in the field of motor insurance and with the substantial net income generated in this account, I regard this as acceptable. I would, however, point out that we deemed it desirable to reserve 50% of the whole premium for the period instead of the more usual 40% as a safety measure.

ACCIDENT INSURANCE ACCOUNT

This account is small and here again, net income has been kept low in the interests of safety of the fund. Again, largely due to the incident of commission earnings a profit of nearly £3,000 was transferred to the Profit and Loss Account.

WORKMEN COMPENSATION ACCOUNT

This is a difficult account to run profitably and we must be careful in underwriting and selection. A loss of some £7,500 was made on the account, but here again, one must not lose sight of the safety margin of 50% of the income reserved for unexpired risks instead of the more usual 40%.

BURGLARY, FIDELITY AND MISCELLANEOUS INSURANCE ACCOUNT

A small account for direct cessions but a substantial one for compulsory cessions. With careful handling this can be a very profitable account and it is pleasing to record a profit of nearly £11,000.

MARINE AND AVIATION ACCOUNT

This account is so unbalanced that we do not think it is in the interests of NICON at this stage in its development to carry large net retentions for our own account. It is very pleasing to record a very substantial profit transferred to the Profit and Loss Account.

GENERAL

To summarise, I think that for the first period of trading for NICON to have a net Profit of some £138,000 can only be modestly described as satisfactory. It should give us hope and encouragement for the future. In a very short time now we shall be moving into new and substantial premises in the commercial centre of Lagos. Due to the unsatisfactory conditions at Awolowo Road, we have not been able to move as fast as many of us would have wished. Now that the staff will be better housed with room for some expansion, we propose during 1972 to enter the private sector of the Insurance market to a substantial extent, and we are proposing to open Branch Offices in many of the major cities in the Federation. We also propose to enter the field of Life Assurance. We feel that there is an untapped field for Life Assurance in this country not only for individuals but also for Pension and Group Life Assurance schemes. Many indigenous companies have entered this field during the last few months and NICON must move quickly to see that they are not overtaken by their competitors.

Finally, I would say that the future for NICON looks rosy and I would like to pay tribute to our Managing Director and his staff for making it possible for me to present such a gratifying picture of the Corporation's activities. I would also like to thank all our clients, brokers, both local and our representatives overseas, for their loyal support and help. It would also not be out of place for me to comment specifically on the Swiss Reinsurance Company of Switzerland and Munich Reinsurance Company of Western Germany, for the great help they gave to NICON particularly in the early days; a help that we shall not forget.

GENERAL REPORT OF THE AUDITORS ON THE ACCOUNTS FOR THE PERIOD ENDED 31st DECEMBER, 1970

(Pursuant to section 24 (3) (a) of Decree No. 22 of 1969)

1. *Preliminary.*—The National Insurance Corporation of Nigeria was established under Decree No. 22 of 1969 with 1st July, 1969 as its commencement date. The annexed Audited Accounts of the Corporation are therefore for the period of eighteen months comprising 1st July, 1969 to 31st December, 1970.

2. *Share Capital.*—The Share Capital of the Corporation is £N1,000,000 divided into 20,000 Shares of £N50 each. The said Shares were on the commencement date of the Decree on 1st July, 1969 deemed 'to be subscribed for, issued and called up in full' but only an amount of £N250,000 was actually paid-up or received from the Federal Military Government up to 31st December, 1970.

3. *Shareholders.*—All the Shares in the Corporation are authorised by the Decree to be taken up by the Federal Military Government. At the date of the Balance Sheet, the Government therefore had an outstanding liability against its Consolidated Revenue Fund in respect of the unpaid amount of £N750,000. We are, however, informed that efforts are being made to collect the outstanding balance due before the end of the current financial year of 1971.

4. *Loan.*—The amount of £N100,000 shown in the Balance Sheet was received from the Federal Ministry of Finance in accordance with the provisions of section 14 (1) of the Decree which stipulates that 'the initial expenses and working capital of the Corporation shall be provided out of such Loan.'

No formal Agreement has been drawn up for the Loan and no rate of interest has been approved as yet by the Commissioner for Finance under the Decree. Nevertheless, provision has been made in the Accounts at the rate of 5% up to 31st December, 1970.

5. *Accrued Liabilities.*—Agreement has been reached with the Statutory Corporation Service Commission as to the amount to be paid by N.I.C.O.N. as its assessed contribution towards that Commission in respect of the period ended 31st December, 1970. Provision has therefore been made for the sum of £N10,000 in the Accounts to 31st December, 1970.

8. *Reserve for Unexpired Risks.*—Generally, the bulk of the Corporation's business came in towards the end of the financial period. In view of the peculiar situation, it has been considered a lot more appropriate to adopt a higher rate of 50% for unexpired risks at the end of the financial period in respect of all classes of business except Marine, Aviation and Transit instead of the customary rate of 40%.

As regards Marine, Aviation and Transit Insurance, the rate of 100% has been adopted as there is always considerable time-lag between the actual occurrence of the liability and the time of notification of such liability, to the insurer.

CHAIRMAN'S REPORT ON 1971 ACCOUNTS

The year 1971 was for this Corporation a period of consolidation in which we analysed our systems, built up our expertise and planned the move of our Head Office into more spacious accommodation in the business centre of Lagos. During the period, we also successfully commenced the handling of the compulsory reinsurance of Fire business from the local market in accordance with the powers vested in us under our Decree No. 22.

It is natural that it is with pride and pleasure that in presenting these Accounts I am able to announce a very substantial profit of over £290,000. The reasons for this are many but part at least of the substantial profit is due to the special reserves that we set aside at the close of our 1969-70 period of trading to deal with unknown factors which it was neither possible nor practicable to have assessed with any degree of accuracy. In the event, our 1969-70 experience turned out to be more favourable than we had expected and our profits for 1971 reflected this favourable trend. That the substantial profit margin pleases me particularly is because of the fact that if NICON is to play the part that the Nation expected it to play it must build up its funds as quickly as possible, commensurate of course with wisdom and prudence, for it is only by so doing that it can increase its capacity and thus reduce the outflow of foreign exchange by way of reinsurance premiums which is so essential to the economy of the Nation.

For 1972 we are planning substantial expansionist activities. We shall, as opportunity and necessity dictate, set up organisations in other major cities within the Federation. We shall concentrate to a greater extent on obtaining business from the private sector and we shall also embark upon Life Assurance. For those who say that NICON should restrict itself to reinsurance operations only, we would simply point out that this was not envisaged when Decree No. 22 was promulgated and I and my Board feel that NICON can and must play its part in all insurance operations in Nigeria without restriction.

Turning now to details of our year's trading, I would mention that we have reserved for unexpired risks on all accounts except the Marine and Aviation Department 50 per cent of the net premium income for the year. This is instead of the more usual 40 per cent and again is a safety measure partly to guard against unknown factors and partly by reason of the fact that the accounts, because of their still relatively small size, are uneven. For the Marine Department we have, in accordance with customary practice, reserved 100 per cent of the net premium for the year for unexpired risks.

Specific comments on each account I make as follows:—

Fire Insurance Account.—The substantial growth in our premium income, both gross and net, is due in part to the steady growth of our direct account but is due largely to the intake of compulsory cessions from the insurance company market which came into effect in accordance with the provisions of the NICON Decree on the 1st of January, 1971. The transfer of £37,000 to the Profit and Loss Account is very satisfactory.

Accident Insurance Account.—It is pleasing to record that both the gross premium income and the net premium income have risen considerably in this department and a profit of some £3,000 has been transferred to the Profit and Loss Account.

Motor Vehicle Insurance Account.—There has been substantial growth in premium income and an extremely satisfactory profit transfer to the Profit and Loss Account. Although Motor insurance business is generally regarded as hazardous, it is possible with careful underwriting and selection to run this account on a profitable basis.

Marine and Aviation and Transit Insurance Account.—Once again we have made a substantial transfer to the Profit and Loss Account though it will be appreciated, that in marine insurance particularly, claims are sometimes not reported and finally settled for some considerable time after an event and it is for this reason that marine accounts are generally assessed over a period of three years.

Workmen Compensation Insurance Account.—This is a relatively small account in which it is not easy to make a profit. For the period ending 1970 we made a loss of some £7,500 but we are glad to report that for the period under review the account has shown a profit of £7,300.

Burglary, Fidelity and Miscellaneous Insurance Account.—Although this account is also a small one it is potentially a very profitable one if care is taken in selection and underwriting of risks. A transfer to Profit and Loss Account of over £14,000 is encouraging.

The Corporation, as I have mentioned earlier, embarks on a substantial expansionist programme during 1972 which will have the inevitable effect of an increase in expenses which in turn will be reflected in the trading results of the Corporation. Coupled therefore with the pride and pleasure that I have in presenting these Accounts which I think augur well for the future of this Corporation, I must add that it will be difficult for us to match these excellent results in the coming year.

It is, I know, normal for Chairman on these occasions to express appreciation for what has been done by the Chief Executive and all his staff. Because it is normal practice, the Chairman's comments are sometimes regarded as mere routine. On this occasion, however, I and my Board wish to underline our pleasure at what has been achieved by our Managing Director, his Management team and all our staff, and to express our appreciation of the excellent work that has been done during the year that I have been reviewing and the quite outstanding results that have been achieved. My thanks also go to our broker friends, to our clients in both the public and private sector and to our colleagues in the insurance market both at home and overseas. Their ready encouragement and support has strengthened us in our efforts to build an insurance Corporation worthy of the high hopes that were placed in NICON when the decision was made to create it.

FINANCIAL YEAR ENDED 31st DECEMBER, 1971
(Made Pursuant to Section 24 (3) (a) of Decree No. 22 of 1969)

1. *Share Capital.*—The amount paid-up on the Share Capital of the Corporation at the end of the financial year under review remained in the sum of £N250,000.

We, however, did find evidence that the balance of £N750,000 authorised under the Decree was received from the Federal Military Government on 3rd February, 1972—that is, after the end of the 1971 financial year.

The Federal Military Government also remained the Sole Shareholders of the Corporation throughout the financial year under review.

2. *Loan.*—Also the Loan of £N100,000 granted towards meeting the initial expenses/working capital remained outstanding at the end of the financial year but we did find evidence that repayment was eventually made on 3rd February, 1972 when the balance of Share Capital was received.

No rate of interest has been specified or approved as yet by the Commissioner for Finance in accordance with the provisions of section 14 (1) of the Decree which established the Corporation but a provision has been made at the rate of 5% in the Accounts under review.
