LIST OF KNOWN AND SUSPECTED CASES OF DEFAULTING ENTERPRISES UNDER SCHEDULE I

Published below is the list of known and suspected cases of defaulting enterprises under Schedule I of the Nigerian Enterprises Promotion Decree. The enterprises affected are located in Lagos, Kano, Ibadan, Kaduna, Jos, Maiduguri, Calabar, Port Harcourt, Benin and Enugu.

2. Confirmed cases have already been sealed up and/or taken over by the Federal Government and will be sold to Nigerians between now and Saturday, August 14, 1976 in accordance with Section 12 of the Nigerian Enterprises Promotion Decree. All interested persons who would want to purchase any of the affected enterprises should contact the Ministry of Trade and Industries in the respective states for more information and necessary action.

3. The Board appeals to everyone, Nigerian and non-Nigerians alike, to report cases of defaulting known to them. The foreign proprietors of the enterprises listed below who may no longer be operating these or any other businesses but are still resident in Nigeria are requested to contact the Nigerian Enterprises Promotion Board Secretariat in Lagos or the nearest State Ministry of Trade and Industry. All foreign proprietors of all other businesses that are operating in contravention of the Nigerian Enterprises Promotion Decree are also advised, in their own interests, to report early to the Nigerian Enterprises Promotion Board Secretariat in Lagos or to the nearest State Ministry of Trade and/or Industry for necessary documentation and instruction.

4. Any attempt by anybody to cover up yet unidentified cases of default will be viewed seriously by the Board.
