WHEREAS by section 48 (2) of the Constitution of the former Mid-Western State of Nigeria as modified by the States (Creation and Transitional Provisions) Decree 1967, and the Constitution (Basic Provisions) Decree 1975 it is provided that the Judges of the High Court of the State shall be the Chief Justice of the State and such number of other Judges (not being less than six) as may be prescribed by law :

AND WHEREAS by section 49 (3) of the Constitution of the former Mid-Western State of Nigeria modified as aforesaid it is provided that if the office of the Chief Justice of the State is vacant or if the person holding the office is for any reason unable to perform the functions of his office, then, until a person has been appointed to and has assumed the functions of that office or until the person holding the office has resumed those functions, as the case may be, those functions shall be performed by such one of the other Judges of the High Court of the State as may from time to time be designated in that behalf by the Supreme Military Council, acting after consultation with the Advisory Judicial Committee :
