Government Notice No. 1565**COMPETITION FOR ENTRY INTO THE
ADMINISTRATIVE AND SPECIAL DEPARTMENTAL
CADRES IN THE BENDEL STATE OF NIGERIA
PUBLIC SERVICE**

The 1977 competition for entry into the Administrative and the Special Departmental Cadres in the Bendel State of Nigeria Public Service will start in January 1977. The Special Departmental Cadres comprises the posts of Assistant Registrar of Co-operative Societies, Produce Officer, Auditor, Inspector of Taxes and Information Officer.

2. The competition will consist of :—

(a) a qualifying written examination conducted by the West African Examinations Council ;

(b) a series of tests and interviews conducted by the Public Service Selection Board ; and

(c) an interview by the Public Service Commission.

Only candidates who attain the qualifying standard in the written examination will be invited for the tests and interviews to be conducted by the Public Service Selection Board. The Public Service Commission will subsequently select, in the light of the performances of such candidates, those who will be interviewed by the Commission.

3. To be eligible to enter for the competition, a candidate, who is not already in the Public Service of the Bendel State of Nigeria, should either possess the following qualifications or be sitting for them in the course of the year, viz :—

(i) for the post of *Administrative Officer, Grade VII* : A degree, preferably in Arts or Economics, from a recognised University ;

(ii) for the post of *Inspector of Taxes or Auditor* : A degree from a recognised University, preferably in Accountancy, Commerce or Economics ;

(iii) for the post of *Produce Officer* : A degree from a recognised University in Agriculture or other suitable discipline preferably Commerce or Economics ;

(iv) for the post of *Assistant Registrar of Co-operative Societies* : A degree preferably in Economics obtained from a recognised University ;

(v) for the post of *Information Officer* : An honours degree, preferably in Arts or Social Science of a recognised University plus evidence of a literary bent.

"Recognised" in the above context means "recognised by the Government of the Bendel State of Nigeria".

4. The purpose of the written examination is not to test the candidates in the subjects which they studied for their degrees, but to test their ability to think

clearly, to understand and write English and also to test their knowledge of current affairs, particularly West African Affairs. Notes for the guidance of candidates, drawn up by the West African Examinations Council will be issued to all candidates by the Council in due course.

5. The written examination will consist of the following papers:—

(i) *English (Precis and Critical Appreciation)* :

This will consist of a fairly long and complex passage and candidates will be required to summarize it in their own words and to make critical comments on its central ideas.

(ii) *Current Affairs* : This will comprise two separate papers, one of which will be a paper of three compulsory questions of the traditional essay type and the other an objective test paper of fifty questions. The questions are designed to test the candidates' intelligent awareness of current affairs which any educated person may be presumed to possess;

(iii) *General* : This will consist of two questions. The first, known as the "Logical Force Passage", will test the candidates' ability to detect illogical thinking and the second, known as "Statistical Inference Question", will test their ability to draw correct inferences from a table of numerical data.

6. The written examination will be held at the following centres : Lagos, Ibadan, Enugu, Benin City, Kaduna, Accra, Freetown, London, Washington and at such other centres as may be determined later. The dates and centres of the sitting of the Public Service Selection Board will be announced later.

7. Candidates will be required to pay a non-refundable fee of ₦12.00. No responsibility will be accepted for money sent in any manner other than the one prescribed in paragraph 8 below.

8. Every candidate who has already applied for appointment to any of the cadres mentioned in paragraph 1 above should, if resident in Nigeria, send to the Secretary, Public Service Commission, Benin City a crossed postal order or money order for the examination fee of ₦12.00. A candidate outside Nigeria should send the fee of ₦12.00 by crossed postal order to the authority to whom he addressed his application. The name of the applicant should be inscribed on the reverse side of the postal order or money order and the serial number(s) of such postal or money orders should be recorded in the accompanying application form or letter.

9. Candidates who have not yet applied but intend to sit for the examinations should send their fees in the manner described above, together with their completed application forms to the Secretary, Public Service Commission, Benin City, if they are in West Africa or to the Nigeria High Commission (Recruitment Section), 9 Northumberland Avenue, London, W. C. 2, if they are in Europe, or to the Chancery, Embassy of Nigeria, 1333, Sixteenth Street, N.W. Washington, D. C. 20036, if they are in the United States of America or Canada. The official application forms are obtainable from the Secretary, Public Service Commission, Benin City, and from any of the Nigerian Diplomatic Missions abroad.

10. Serving officers will be advised later about the special arrangements being made for them.

11. The closing date for the receipt of the application forms and fees will be 5th November, 1976. Late entries will not be accepted.

12. Instructions as to the date, time and place of the examination will be sent direct to candidates by the West African Examinations Council.

Other requirements.—Candidates must not be less than 28 years old and must be of good character. They must also be certified by a Government Medical Officer as being physically and mentally fit for service in the Force. Candidates should not be less than 1.67 metres tall with an expanded chest measurement of at least 87 cm. They must possess the professional driving licence Group C or its equivalent.

(iv) *Chief Statistician.*—As 3 (i) above plus at least 12 years' post-qualification working experience in a statistical institution.

(v) *Assistant Chief Statistician.*—As 3 (i) above plus at least 10 years' post qualification working experience in a Statistical Institution.

(vi) *Principal Statistician.*—As 3 (i) above plus at least 7 years' post-qualification working experience in a recognised Statistical Institution.

(vii) *Senior Statistician.*—As 3 (i) above plus at least 5 years' post-qualification working experience in a recognised Statistical Institution.

(viii) *Statistician, Grade I.*—As 3 (i) above plus at least 2 years' post-qualification working experience in a recognised Statistical Institution.

(ix) *Statistician Grade II.*—As 3 (i) above.

4. Duties :

(i) *Director.*—Executive Head of the Bureau ; General Supervision of all Divisions of the Bureau and its Units in Federal Ministries. (ii) *Assistant Director.*—Supervision of one Division of the Bureau ; Preparation of work programmes ; determination of priorities and implementation ; Assistance to Director in formulation of policies ; Technical Advice to other agencies ; Attendance at local and international meetings ; General Administrative matters relating to Units under Division.

(iii) *Data Processing Controller.*—Head of the Computer Centre ; Overall control of activities of the installation ; Chief Adviser to top Management of Bureau on objectives, obligations, needs and long term development ; Ensuring timely satisfaction of information needs of user ; Formulation/execution of policy on training ; Ensuring full and efficient utilization of computer facilities and determination of priorities between competing users ; Attendance at relevant interdepartmental, international meetings ; General administrative matters.

(iv and v) *Chief Statistician/Assistant Chief Statistician.*—Supervision of two or more Units of a Division ; Supervision of statistical activities of zones of states (i) zone will consist of a minimum of 3 states ; Formulation/execution of work programmes ; Attendance at technical subject-matter committee ; Local/international meetings, etc. ; Control of a number of subordinate senior staff—Principal Statisticians, etc. ; Preparation of technical reports ; General administrative matters relating to the Units ; General assistance to Assistant Director.

(vi and vii) *Principal Statistician/Senior Statistician.*—Head of a Unit (A Unit consists of Sections, each dealing with specific areas of statistics) or a State branch office ; Planning, preparation and execution of statistical projects or surveys ; Control of subordinate staff ; Preparation of good and timely statistical reports ; Liaison with public on technical matters ; Attendance at technical subject-matters committee meeting conferences, etc. General administrative matters relating to Unit.

(viii) *Statistician, Grade I.*—Head of one section ; Planning preparation and execution of surveys, etc. under the supervision of a Senior Statistician or Principal Statistician ; Preparation of good and timely statistical reports ; Control of subordinate staff.

5. *Conditions of service.*—All posts are pensionable and new entrants to the Public Service will normally be on probation for two years. Other conditions will be as prescribed for the time being for officers of equivalent grades in the Federal Public Service.
