He is, among other things, the Accounting Officer of the TRIBUNALS Sheriff, Taxing Master of interlocutory proceedings, Commissioner for Oaths and in appropriate cases admiralty Marshall.

(ii) Deputy Registrars.—Successful candidates will be required to head the administrative and control of staff of the National Industrial Court or of the Industrial Arbitration Panel to whichever of the TRIBUNALS he is deployed, under the direction of the Chief Registrar. He will also be responsible for giving necessary directions to parties to a trade dispute before the Panel or the Court and to do all things that are necessary for the smooth and expeditious hearing and final disposal of trade disputes, including research in case laws to be available to Members and Arbitrators of the Industrial Court and Arbitration Panel respectively to facilitate the writing of Awards.

Salary scales,—(i) Chief Registrar—Grade Level 15—N10,000.

(ii) Deputy Registrar-Grade Level 14-N8,870.

5. Conditions of service.—The posts are pensionable and new entrants to the Public Service will normally be on probationary appointment for two years. Other conditions will be as prescribed for the time being for officers of equivalent grades in the Federal Public Service.

6. Methods of application.—(a) In Nigeria : Applications from candidates not in Government Service should be completed on official form obtainable from the Secretary, Federal Public Service Commission, Independence Building, Lagos. (b) Overseas : Application should be completed in duplicate on official form obtainable from the Recruitment Attaché, Nigeria High Commission, London W.C. 2.
