

THE FEDERAL REVENUE COURT DECREE 1973
(1973 No. 13)

LIEUTENANT-GENERAL OLUSEGUN OBASANJO,

WHEREAS by section 1 (2) of Federal Revenue Court Decree 1973 it is provided that the Federal Revenue Court shall consist of the President and such number of Judges (not being less than 4) as the Head of the Federal Military Government may by order prescribe :

AND WHEREAS by section 2 (1) of the aforesaid Decree it is provided that the President of the Federal Revenue Court and the other Judges of that Court shall be appointed by the Supreme Military Council, acting after consultation with the Advisory Judicial Committee :

NOW, THEREFORE, THE SUPREME MILITARY COUNCIL, acting after consultation with the Advisory Judicial Committee, do hereby appoint PATRICK CHUMA AKPAMGBO a Judge of the Federal Revenue Court with effect from 12th day of July, 1976.

GIVEN under my hand and the Public Seal of the Federal Republic of Nigeria at Lagos this 10th day of November, One thousand nine hundred and seventy-six.

1.
