Since the promulgation of the above named decree in November 1974, and this Ministry's notice No. 832 of 24th June, 1976 there have been numerous enquiries from intending importers of food, drugs and cosmetics on the implications of section 8 sub-section 2, of the decree as regards the format of certificates of manufacture and free sale acceptable to the Ministry.

In order to remove the difficulties now encountered by importers it has been decided that the provisions of that section shall be deemed to have been complied with if the articles on importation are accompanied by a combined certificate based on the format shown below.

The original certificate shall accompany the products on first importation by an importer, but on subsequent importations photocopies shall be sufficient.

All importers are advised in their own interest to adopt this format as goods not accompanied by this type of certificate may experience delays on arrival, or may even be refused entry into the country.

Importers are also reminded that cosmetics and pesticides of all types are covered by the provisions of the decree.

- (17) Canned beer and canned stout ;
- (18) All non-alcoholic beverages including all soft drinks and waters excluding fresh water and vitaminised malt extract drinks ; (Tariff Nos. 20.07, 21.07B, 22.01 and 22.02) ;
- (19) Brandy, bitters, liquours, rum, whisky, schnapps, gin and other potable spirits excluding potable spirits imported at high strength for local bottling by a manufacturer approved in that behalf by the Commissioner (Tariff Nos. 22.08 and 22.09).

2. In order to obtain a licence, importers should obtain from this Ministry or from our Trade Offices in the States application forms which should be duly completed and submitted direct and not through intermediaries with the following attachments :—

(a) Evidence of utilisation of previous import licence and/or previous importation of the item of import. This must be supported by the relevant customs Bills of Entry, Bills of Lading and Invoices.

(b) Evidence of registration of Business Name or incorporation of company where not previously submitted ;

(c) In case of Industrial Application, evidence of non-availability locally of the raw materials required.

In addition to the above documentary evidence, applicants are enjoined to request their bankers to send directly to this office a report on their credit worthiness and main line of business.

3. Applicants are reminded to indicate the amount they required for each specific item for which they are applying. The business or registered address of the applicant must be stated. Post Office Box or Private Mail Bag numbers only will NOT be accepted.

4. Applicants resident in the States are strictly requested to obtain their application forms from the Federal Trade Offices in their respective States and to submit the completed forms to the said offices.

5. The closing date for submission of applications is 31st May, 1977. However, applications for Industrial raw materials will continue to be entertained as the need arises.

6. Importers are reminded that it is obligatory to obtain import licence in respect of restricted items of import BEFORE placing orders abroad. Any restricted imports shipped in contravention of the licensing regulations will be subjected to prescribed penalties.
