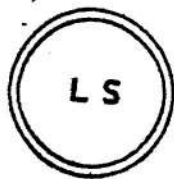

1. This strip of land is situated in Bendel State. The route is demarcated on the ground with pillars in concrete and hereinunder described.

2. DESCRIPTION

All the strip of land approximately seventy three point five kilometres long, is situated in Bendel State. The route traverses dry land and swamp, and is shown on the Licensee's Drawing numbers E-2A-10/001-9014 and E-2A-10/001-9015.
