3.1.1 Taking charge of specified subject/ subjects within a Section or Division of a Ministry/Department and applying the General Orders, Public Service Commission Regulations, Financial Instructions, Circulars, etc. in treating matters in any of the following fields :

(a) Personnel or General Administration;

(b) Accounts ;

(c) Audit ;

(d) Tax/Revenue.

3.1.2 Supervising and co-ordinating the duties of a number of officers under them.

3.1.3 Assisting senior officers as may be required or directed.

3.1.4 Performing other duties as may be required or directed.

3.2 Executive Officers :

3.2.1 Taking charge, under supervision, of specified subject/subjects or schedule of duties within a Section or Division of a Ministry/Department and applying the General Orders, Public Service Commission Regulations, Financial Instructions, Circulars, etc. in treating matters in any of the following fields :--
