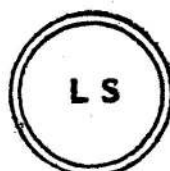

(4) *Senior Registrars.*—In charge of :

(i) editing judgments for law reporting, research in case laws which will be available to Judges to facilitate writing judgment ; or

(ii) Assessment of papers filed and collection of fees and fines. Auditing Queries. Exhibits and Receipt for money paid out of Court to party. Bond for security for charges. Commissioners for Oaths. Admiralty matters. To initial papers for filing.

(5) *Higher Registrars.*—

(i) Required to work in the Litigation and Management sections of the Court and take part in the day to day administration of the Court as will be directed by the President and the Chief Registrar ; or

(ii) To sit in Court, Bail Bond, warrants. Warrant to carry out sentence. Warrant to production, warrant where witness has not obeyed summons, etc. Drawing up of Court orders. Commissioners for Oaths.
