APPLICATION FOR AN OIL PIPELINE LICENCE

Notice is hereby given in accordance with Section 8 of the Oil Pipelines Act (Cap. 145) that the Shell-BP Petroleum Development Company of Nigeria Limited whose registered office is at 21-22 Marina, Lagos has applied to the Petroleum Inspectorate, N.N.P.C. for the grant of a licence to enter upon, take possession of and use for 20 (twenty) years a strip of land for the purpose of laying an 8-inch diameter Angalalei Delivery Line.

The strip of land is situated in the Rivers State. The route is demarcated on the ground with pillars in concrete and is herein described.

DESCRIPTION

1. All that strip of land approximately 0.960 kilometres long situated in the Rivers State.

The route is shown in the Licencee's drawing No. 12666 dated March 1978.

The width of the strip of land to be occupied will be of 15.25 metres.

The co-ordinates of the termination point are : 383169ME 115223MN (P.I. 4).

2. A copy of the plan of the pipeline route identifying the land affected can be inspected during all normal working hours at the offices in Lagos, Warri and Port Harcourt of the Petroleum Inspectorate and at the offices of the Ministry of Lands and Housing (Lands Division), Port Harcourt.

3. Any person who considers that his land or interest in land will be injuriously affected by the grant of this licence should lodge orally or in writing not less than seven days before the hearing date in paragraph 5 with the Ministry of Lands and Housing (Lands Division), Port Harcourt, notice of the objection, stating his interest and the grounds of objection.

4. Any public officer who receives a verbal objection in the course of his duties should record the name and address, interest and grounds of objection and forward such details to the Ministry of Lands and Housing (Lands Division), Port Harcourt and/or the nearest office of the Petroleum Inspectorate, N.N.P.C.

5. The representative of the Lands Division of the Ministry of Lands and Housing, Port Harcourt will enquire into objections (if any) duly lodged in accordance with paragraphs 3 and 4 above at his office at Port Harcourt at 10 a.m. on the 28th day of December, 1978, giving all parties an opporturity to be heard. A report thereof should be sent without delay to the Head, Petroleum Inspectorate, Nigerian National Petroleum Corporation, Lagos.

COUNCIL OF LEGAL EDUCATION INFORMATION CIRCULAR No. 5 PRELIMINARY COURSE LEADING TO ADMISSION TO THE NIGERIAN LAW SCHOOL

PURSUANT to the decision of the Federal Military Government, the Council of Legal Education is organising, and proposes to run within the current academic session, a preliminary course in law intended to enable holders of decrees in law awarded by universities and other institutions outside the Common Law system to acquire the such patent acquaintance with the Common Law as is prerequisite for admission to the one-year professional training for prospective entrants to the legal profession in Nigeria now ordinarily undertaken by the Council of Legal Education at the Nigerian Law School. The proposed course will be run at the Nigerian Law School.

All persons of Nigerian origin who hold themselves out as graduates in Law of universities or other institutions outside the Common Law system are hereby called upon to apply for admission to this preliminary course. All such persons are to forward their applications to the Secretary to the Council of Legal Education, Nigerian Law School, Victoria Island, P.M.B. No. 12610, Lagos, so as to reach him not later than 30th November, 1978 and each application should be accompanied by :---

(a) a photo copy of the applicant's degree certificate in law or other qualification in law duly certified by a Commissioner for Oaths or a Notary Public in Nigeria.

(b) a list of the subjects studied in the course leading to the aforesaid degree with a statement as to the years or periods in which particular subjects were studied, duly countersigned by an official of the university or institution at which the applicant purports to have studied.

(c) a statement from the Embassy or such other establishment representing in Nigeria the country in which the applicant purports to have undergone his legal education indicating the relationship between such university or other institution and the professional body regulating the admission of persons to practise as Barristers-at-Law or its equivalent in such country.

After due scrutiny of the certificate and other material by the Council of Legal Education persons so applying who are considered by the Council to be persons possessing such qualifications as can be accepted for purposes of the preliminary course so intended will in due course be called upon to present themselves for registration with a view to commencing studies on a day to be announced later, subject to such conditions and stipulations as the Council of Legal Education may prescribe, having regard to all the circumstance of the situation.
