4. *Duties.*—(a) Assistant Technical Officers (Electronics) are engaged in the maintenance and repairs of electronic equipments used in Meteorology. These include Wind Finding Radar, Storm Detecting Radar, Facsimile Recorders, SSB Transceivers, and Radio Sonde Ground Equipment.

(b) Technical Officers (Electronics) in addition to duties enumerated in (a) above supervise Assistant Technical Officers and other subordinate Staff.

(c) Higher Technical Officers (Electronics) perform similar duties as in (a) and (b) above. In addition, they are responsible for the installation and modification of the above equipments. They also bear the overall responsibility for the smooth and efficient running of the Electronics Workshops.
