5. Conditions of Service.—All posts are pensionable and new entrants to the Public Service will normally be on probation for two years. Other conditions will be as prescribed for the time being for officers of equivalent grades in the Federal Public Service.

6. Method of applications.—(a) In Nigeria—Applications from candidates not in Government Service should be completed on official forms obtainable from the Secretary, Federal Public Service Commission, Independence Building, Lagos.
