TRANSLATORS TRAINING PROGRAMME AT ECA SECOND COURSE

In July 1978, the United Nations Economic Commission for Africa (ECA) inaugurated a training programme for African candidates, aimed at preparing them to sit the standard official United Nations competitive examination for the recruitment of English and French translators/precis writers.

A nine months course for some ten English-speaking and French-speaking participants is given under this programme at ECA Addis Ababa. It consists not only of lectures designed to familiarize the trainees with the past and present activities of the United Nations and to provide them with other relevant information but also and basically of practical exercises embodying the principles and techniques applied in the organisation for translating and summarizing (precis writing).

The second course at ECA will begin in the autumn of 1979. To be eligible for this course, applicants offering English as their main Language must / the following qualifications :

- (a) A perfect command of English
- (b) Excellent knowledge of French and of another official language of the United Nations (Arabic, Chinese, Russian or Spanish)
- (c) A degree or similar diploma of a university or equivalent institution at which English is the language of instruction.

All applications will be screened and qualified candidates will be given a written test in May 1979 designed to evaluate their potential to develop the translation and precis-writing skills needed by the United Nations.

Candidates successful in the written test will be interviewed and those best suited for the course on the basis of the regular criteria for the recruitment of Translators/Precis writers in the United Nations will be selected.

Eligible applicants interested in sitting the written test should submit their applications to Mrs G. Miliband, Recruitment Officer, United Nations, New York, N.Y. 10017, USA.

Applications should be accompanied by a P. 11 form obtainable from any office of the United Nations Development Programme (UNDP) or direct from ECA

Candidates who are successful in the standard official UN translators examination at the end of the training period will be assigned to ECA for an initial period of five years. During their first two years of service they will be detailed for a period of up to six months for further training in the appropriate translation service at the UN Headquarters.

This programme for training Translators/Precis writers at ECA was approved in 1977 by the General Assembly of the United Nations which reaffirmed the concern frequently expressed within the organisation at the lack of African translators, not only in the United Nations generally but also and especially in the ECA where the official languages are Arabic, English and French.

Final date for the receipt of the applications is 16th February, 1979.
