APPLICATION FOR AN OIL PIPELINE LICENCE

Notice is hereby given in accordance with Section 8 of the Oil Pipelines Act (Cap 145) that the Shell-BP Petroleum Development Company of Nigeria Limited whose registered office is at Freeman House, 21-22 Marina, Lagos has applied to the Petroleum Inspectorate, N.N.P.C. for the grant of a licence to enter upon, take possession of and use for 20 (twenty) years a strip of land for the purpose of laying an 8.625" O.D. pipeline, approximately 1.85 kilometres long and 15.25 metres wide, running from a point in the proposed Nembe Creek North-West Flowstation to the Nembe Creek main manifold of the proposed Nembe Creek to Cawthorne Channel Trunkline, all in the Brass Local Government Area of the Rivers State of Nigeria.
